Out of an abundance of caution, Marble Falls ISD is notifying you that school enrollment documents are considered a Government Record. Falsification of enrollment records is a criminal offense under Section 37.10 of the Texas Penal Code- *Tampering with Governmental Record*. Section 37.10 states:

A person commits an offense if he/she

- (1) Knowingly makes a false entry in, or false alteration of, a governmental record and/or
- (2) Makes, presents or uses any record, document, or thing with knowledge of its falsity and with intent that it be taken as a genuine governmental record.
