Dear Residence Owner,

This letter is to serve as a courtesy reminder regarding the Statement of Residency form you submitted to Marble Falls ISD on behalf of students residing in your home within the Marble Falls ISD boundaries.

Out of an abundance of caution, Marble Falls ISD is notifying you that school enrollment documents are considered a Government Record. Falsification of enrollment records is a criminal offense under Section 37.10 of the Texas Penal Code-Tampering with Governmental Record. Section 37.10 states:

A person commits an offense if he/she

- (1) Knowingly makes a false entry in, or false alteration of, a governmental record and/or
- (2) Makes, presents or uses any record, document, or thing with knowledge of its falsity and with intent that it be taken as a genuine governmental record.

As part of the Residency Statement you acknowledged that Marble Falls ISD will send a representative to your home at any given date and time to verify the residence of the student(s). If during the home visit we determine that the student(s) are not living at the residence as stated, Marble Falls ISD will withdraw the student(s) and may also pursue Felony charges under Section 37.10 of the Texas Penal Code.

If your residency situation has changed and the submitted Residency Statement form is no longer applicable, please contact the campus registrar immediately to update them of the change.
