WHAT IS TITLE?

Mt. Pleasant Elementary School is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support state and local school reform efforts tied to challenging state academic standards to reinforce and enhance efforts in teaching and learning for students. Title I program must be based on effective means of improving student achievement and include strategies to support parent and family engagement.
