## **Transportation Rules**

## THIS FORM MUST BE COMPLETED FOR EVERY STUDENT, EVEN IF THEY DO NOT RIDE A BUS

The purpose of bus rules is to aid in transporting students to and from school safely. (Most injuries or fatalities occur while students are going to and from the bus stop.) It is most important that parents, students and drivers cooperate to provide a safe transportation. Please discuss these and other applicable rules with your children to help them understand their necessity.

- Students should be prepared to board the bus at the usual time at the approved bus stop. The bus driver cannot wait for those
  who are tardy.
- 2. Students who must cross the roadway to catch the bus or return home must cross only in front of the bus.
- 3. The driver is in full charge of the bus and riders. Each student may be assigned a seat.
- 4. Students are responsible for understanding and observing bus rules and conduct. (Not limited to this list only. See the Maury County Public Schools Student Handbook.)
- 5. The right of students to ride the bus is conditioned on their good behavior and observance of rules.
- 6. Should any student violate bus rules, it shall be the duty of the driver to warn the student and/or report such violation to the principal. Disciplinary action may include revoking bus privileges.
- Pets, toys, balls, balloons, sports equipment, skateboards, glass containers, radios, cassette players, boom boxes, or any large objects, including band instruments, are not permitted on the bus. (Exceptions must be approved by the Principal / Transportation Department Supervisor.) Soft drinks and food products are <u>prohibited</u> (except student lunches.).
- Profanity, violence, use of tobacco, use of vaping devices, possession of weapons, possession or consumption of alcoholic beverages or drugs is <u>prohibited</u>.
- 9. Unnecessary conversation with the driver and moving about while the bus is in motion or extending arms or head out windows are **prohibited**.
- 10. Students must ride the same bus morning and afternoon except upon written request approved by the principal. Alternative destinations must also be approved by the Principal and the Transportation Department.
