Background and Purpose

William "Billy" Crowe

Billy Crowe was born and raised in Maury County and was a graduate of Spring Hill High School Class of 1950. He joined the Army National Guard and the U.S. Army 101_{st} Airborne Division and served in the Korean War. He was married to Ms. Jean Crowe for 69 years, and together they built a life as dairy farmers for over 50 years. Billy Crowe was the first person in Maury County to be presented with the Outstanding Young Farmers of the Year award by Farm Bureau. Later in life, Billy Crowe also became a successful realtor and co-owner of Crowe-Potts Realty. He loved being a farmer and a realtor and knew Maury County well. He was a fun-loving guy whose favorite past time was fishing with his buddies. He was a member of the Herbert Griffin American Legion Post 19, charter member of the Spring Hill Lions Club, and a member of Spring Hill First United Methodist Church. Billy Crowe's family is proud to offer a scholarship in his honor to a young person from Maury County.

Eligibility

The applicant must be a current resident of Maury County Tennessee with plans to pursue a post high school degree or certificate at a community college, college or university, or technical school. The applicant must be a high school senior or recent GED graduate without full time postsecondary experience.

Applicant should have applied to a post-secondary program, and acceptance will be verified before scholarship is awarded.

Preference will be given to students with an Agriculture background or interest in studying an Agriculture related field, but others are welcome to apply.

Preference will be given to applicants who plan to be full-time students, but part-time students may also apply.

Preference will be given to students showing financial need.

Applicants with less than perfect academic records are encouraged to apply.

All applications must be complete and contain all required signatures.

Certification

The application MUST be certified as eligible by the applicant's guidance counselor, or equivalent certifying official if home schooled or a GED recipient.

Amount of Award

One scholarship in the amount of \$1,000 will be awarded annually.

Due Dates

Applications will be due on April 1 each year. Awards will be announced by May 1.

Use of Award

This award may be used toward tuition, fees, instructional materials or supplies. All awards will be paid directly to the institution of enrollment from the TN 4-H Foundation.
