CRIMINAL JUSTICE TODAY, INTRODUCTION TO CRIMINAL JUSTICE

Description:

Criminal Justice II will offer an in-depth study of criminal justice careers in which current criminal justice careers issues will be discussed and debated. Local, state, federal, and international law enforcements will be analyzed. Subject matter will include a comparison of the criminal justice careers in the United States with other countries. Students will have opportunities to participate in field trips with criminal justice careers emphasis. Course content will introduce new technology, effects of forensic analysis, and career opportunities. The course content will include information for planning, managing, and providing judicial, criminal justices.
