- F. High School Student Organization Report by Edwin Melara

Edwin Melara introduced himself as the Student Organization representative. He reported that in the past few weeks there were a lot of accomplishments and events at the high school. The second semester began and marking period 2 report cards were posted last week. We had our third advisory session. The advisory sessions are monthly sessions we have with our advisors. We talk about growth mind set and things we can do to improve our ability to succeed. For the 8th and 9th graders the session focuses on learning from our mistakes and to accept positive feedback and criticism. And for the upper classmen, we adjusted their session based on their feedback. They focused on obstacles and how to overcome them. Dr. Dewey is coming to the high school to talk about the dangers of substance abuse. The senior awards applications were recently uploaded on the high school webpage. These applications go for senior college scholarships. The cap and gown information is also on the high school webpage. The student organization is getting ready for the Battle of the Classes which is an annual event. All the grades compete against each other in field day events and activities. The theme this year is decades. Each grade will be assigned a different decade. Battle of the Classes is March 2nd. The week before the battle is spirit week where each day will be a different theme day. This past month alumni from the Class of 2017 came to the high school to tell about their college experiences and gave advice. In science research, many students were selected as junior science and humanities semi-finalists. He spoke about senior projects. The student service center is a very strong program which other districts do not have. The Ronald McDonald House has cooked dinners for children seeking medical treatment at the Cohen's Children's Hospital. We have lunch bunches every month where students have lunch and have conversations with the senior citizens. After lunch the students made valentine day cards for veterans. Students who are new to the community have opportunities to participate in the student service center especially those who have limited English ability. This project is called the One World program. Along with some other volunteers, students work in creating a project such as cards for veterans and soldiers overseas. They do a good deed together and by doing this they can make new friends and improve their conversational skills. The In Youth Board visited the Mary Brennan Inn to help restock the food pantry. The Computeers help senior citizens with their electronic devices. Senior citizens are welcome to come to the high school every couple of weeks. Another program the student service center has is Spark. We collaborate with students from Carle Place to work on a common project. One of the projects was baking cookies for the Ronald McDonald House, as well as visiting the Meatloaf Kitchen in the city. There is also a nursing home visiting program. Volunteers visit the Sun Harbor Nursing Home. Students talk with the senior citizens and help them with their cell phones and iPads. The senior citizens enjoy having the students

visit. In athletics, the varsity wrestling team qualified for the team double dual championship in January. Unfortunately, they were defeated by Massapequa. The bowling team will be competing. Some track students will advance to the county track team. Later this week the girls and boys basketball programs will host West Hempstead High School for the annual Reggie Carter game. The fine and performing arts department will be hosting a string night, jazz night and choral night. Students will have the opportunity to register for NYSSMA. The 8th and 9th grade musical will be the Adams Family. The library media center keeps expanding. Students competed in the first school chess tournament. Technology at the high school also keeps expanding. Edwin stated he has highlighted a few of the things going on at the high school. He thanked the board of education and Dr. Nagler for having him here this evening. Dr. Nagler stated it is always a pleasure to have Edwin speak at our meeting. Ms. Napolitano stated that Edwin's report is very thorough and she truly enjoys it.

G. BOE Reports

a. Comments from Board Trustees

Brian Widman reported he attended the high school PTSA meeting. Some important dates are March 20, the Chipotle fundraising night. May 18th is spring cleanup where gently used clothing will be collected and then donated. This Saturday is the SEPTA Pancake breakfast at the Applebee's in Westbury. He stated the middle school musical, Aladdin, was fantastic. This past weekend the high school hosted the First Lego League Qualifiers; two on Saturday and one on Sunday. There were about 100 teams made up of teams from different districts and organizations across long island. Mineola had 4 teams competing on Sunday. Unfortunately, they didn't do as well as they had hoped but I think they all had fun and learned. The Jr. First Lego League Tournament is on March 3rd.

Cheryl Lampasona attended Hampton's Family Math Night. Over 70 families attended even though it was a cold night. It was well attended and well organized by Ms. Maravel. Ms. Lampasona spoke about how amazing the middle school play was. She thanked everyone involved.

Patrick Talty spoke about the sign-a-long he attended at Meadow Drive back in December. The sing-a-long was fantastic. He thanked Dr. Fleischmann for a beautiful morning. Before Mr. Talty left Meadow, he had the pleasure of seeing our music teachers play Christmas songs. He gave us an ST Math update.

Dr. Margaret Ballantyne-Mannion stated the middle school play was so amazing. She said it's hard to believe that the students were only 5th, 6th and 7th graders. The students always blow her away. Dr. Ballantyne-Mannion stated it's amazing how many people volunteered for the play and the Lego events. She thanked all the volunteers. She is looking forward to attending the writing celebrations this week at Jackson Avenue and also looking forward to Jazz Night. She wished everyone a happy and healthy winter break.

b. Comments from Board President

She said she will piggyback about all the wonderful things said about the play. She thanked Mr. Owens, Mr. DeLuca and Aislinn Oliveri. She stated everyone can certainly appreciate the tremendous amount of work that goes into the play. She said it's wonderful to see the joy of the students and thanked everyone. She is looking forward to the Mustang Stakes on Saturday and the SEPTA breakfast.

c. Comments from Superintendent

Dr. Nagler stated he wanted to begin the evening by recognizing Anthony Regueiferos, our systems engineer who is employed by Core BTS, our techology integrator. Anthony is an intrical part of our district. He recently received recognition and an award from Core BTS. Dr. Nagler asked Mr. Gaven to say a few words about Anthony's role in the district and the award he received from Core. Mr. Gavin started by saying as he listened to all the board reports that all centered around the fact that we have special, unique and giving people in our district that makes us so special. Mr. Gaven said Anthony is also one of those special and unique people. Anthony demonstrates a comprehensive understanding of technology systems, of how to build a safe, secure and reliable network. Anthony dedicates his time to Mineola in a number of ways. He was recognized by his company for spear heading interns in our Queensborough Community College program. He also works Thursday evenings with our robotic teams on his own time and his own accord. He has a tremendous amount of integrity and works very hard for us to make our community a special place. Mr. Gaven thanked Anthony and would like to recognize him for his work not only for winning the Core I award but for being a special part of our district. And stated we are Mineola Proud of Anthony.

Dr. Nagler stated Anthony is 24/7. The network never sleeps, our technology problems never end and he is always there to help. Dr. Nagler stated that he has been in charge of technology in this district for many years. We have been partners with Core since 2005 and we have not had a more knowledgeable dedicated systems engineer than Anthony. And Dr. Nagler stated he can say this in front of people he respects very much. Dr. Nagler stated we do not have issues because of Anthony. Dr. Nager he is very proud to recognize Anthony this evening.

Dr. Nagler reported we will be hosting a Digital Promise Twitter chat February 28th at 9:00 p.m. It is also jazz night which Dr. Nagler is participating in but he will be available for the twitter chat. It will be about our growth mind set and we will have a unique feature which will be unlike most twitter chats with teachers and interesting discussions on how we are implementing our initiatives this year.

Dr. Nagler received a flyer from Ms. Burke and Ms. Rudnet about the Macaroni Night which will be March 1st the night of our next board meeting. It was decided that the board meeting will be held at Willis Avenue at 7:30 instead of 7:00 p.m.

Dr. Nagler spoke about Robotics and Mineola's roll in Robotics. The First Lego League is a national organization which we are very committed to it. We have 8 junior FL teams at Jackson and 4 teams at the middle school. We have dedicated staff and we would like to be able to accommodate more children. No other school has this many teams. Some communities may have more teams but they are not school based. We also have the FTC which is the next progression which is available to 8th and 9th graders. Our team this

year is a second year team and has done exceptionally well. They are in the championship round in Smithtown on Sunday. This progresses to the FRC which is the granddaddy of the competition where the robot is half the size of this table. Dr. Nagler feels that one day we may have a Robotics Parent Group just like we have music parents and the booster club. He stated we are going to carry this from grades 3 to 12 so there is a progression and a pathway for kids to follow and enjoy and challenge themselves in computer science robotics and building. He stated this will be great for the children.

Dr. Nagler stated he also had to talk about the middle school play. One third of the children in the building participated in the play. He stated it is unfathomable that we do this. This is so special for our children and the inclusiveness of this. He said he has to hand it to Mr. DeLuca how far the middle school plays have come. Kudos to everyone involved. He is super proud we are able to support this.

If the board has not read the latest issue of Fusfoo, the high school newspaper, there is a fabulous article by Jennifer Moglia called Life from the Eyes of a Female Sports Fan. It's a very good read. She is an exceptional writer and he thanked Dr. Smith for pointing it out to him and telling him to read it. Dr. Nagler said he is going to see Jennifer to personally congratulate her.

Dr. Nagler reported that next week, at the AASA Convention which is the national superintendent's organization, we will be featured as one of the innovative school districts in our country. The organization sent someone to write a case study, who spent two days in our district. He wrote a beautiful case study about Mineola which was very flattering. Dr. Nagler was very impressed. From this, Dr. Nagler was invited to sit on a panel to speak about Mineola in Nashville which he will be doing the end of next week. He always looks forward to representing our district.

Dr. Nagler spoke about the article in today's Newsday regarding students going to college. Mineola was ranked sixth on long island with a 97.9% of students attending colleges. He said Kudos to our teachers and administrators.
