PARENTS AND COMMUNITY MEMBERS-

September 28, 2018

The 2018-2019 school year is moving along at full speed! We have had a wonderful start to our new school year. Here is just a sampling of some of the exciting things happening in the Nestucca Valley School District.

BOND- The sale of the bonds was very successful. Our bonds were in such high demand we made an additional 3.69 million in premiums and were able to hold the price per assessed value of property to .98 cents per 1,000. Our initial projection was .99 cents per 1,000, so this is a savings for property tax payers. As a district we will be treating the extra 3.69 million as a contingency fund for our work. Construction costs are skyrocketing, so we will remain conservative with our scope of work and how we thoughtfully allocate funds.

We have hired the architect and engineering firm DLR Group and the project management firm Day CPM to work with on this project over the course of the next three years. We are currently in the "Pre-Design Phase" of planning, this phase will conclude in November, at which point we will have documents that we can share with the community. Once Pre-Design planning is done, we will then begin the schematic design phase. We are currently projecting a close out to all work for January of 2021. We will continue to update you regularly on the milestones we reach on this project.

FOOD SERVICE- As you may have heard, the District has revamped our food service program. The elementary school has qualified for a program that provides all students with no charge breakfast and lunch for the next four years. Our JRSR High students have also been enjoying no charge breakfast and lunch so far this year. However as of October 1st lunch at the JRSR High will again have a cost of three dollars. Breakfast will continue to be free to all students every school day this year. Families who have completed a free and reduced form, and qualified, will eat for free at the JRSR High.

If you as a family did not fill out a form for your JRSR High student, you can still do so. The more forms that we are able to fill out the more likely we are to qualify the entire JRSR High student population for the program currently providing no cost breakfast and lunch at the elementary. Every time your child eats a meal at either campus, the school district is reimbursed money, creating a fiscal situation that allows us to continue to grow our food service program. Please encourage them to eat breakfast at school.

"Learners Today, Leaders Tomorrow"

We are also excited to announce that the district will soon be offering an additional meal. This exciting new program will take place at the end of the school day and will provide a snack/supper at no charge to all students. We are hoping to be up and running in the month of October. It will be a "grab and go" meal that the kids will consume prior to getting on the bus. An example would be a pizza stick, bag of carrots and juice or milk. Once again, every time one of our students eats this snack, we are reimbursed money by the state that makes our food service program more financially stable. Please encourage your children to eat the school supper.

PROMISE OF OREGON- This year our district will be one of five school districts that is featured by the Oregon School Boards Association (OSBA) in their Promise of Oregon promotion. Students from each building will be videotaped, photographed, interviewed by OSBA and celebrated throughout the state. Once OSBA begins to publish pictures and interviews we will share them on our website. A limited number of students will be featured, so not all students were given sign-up sheets. If your child did bring home a Promise of Oregon packet, and you would like them to participate, please fill out the paperwork and return it to the school office by Tuesday, October 2nd.

21 CENTURY AFTERSCHOOL PROGRAM- We will begin sending information home concerning the afterschool program, the first week of October. Soon you will be able to reference our website for information as we will be adding an after school program tab.

LEARNING- Were are three weeks into our new academic year, and learning is happening. Our three newly adopted curriculums, math, science and health have been needed and welcome additions to our resources.

Thank you community members for all of your support and help in making great things happen for our students! The 2018-2019 school year is going to rock!

2018-19 Annual Notice for Statewide Tests

ALL STUDENTS GRADUATE PREPARED

In 2010, Oregon adopted higher K-12 standards in English Language Arts and Math to ensure all students move from grade to grade with the academic knowledge and skills necessary for success beyond high school. Because we raised the bar for what we expect students to know and be able to do, we have also changed the way we measure student progress through our state tests, known as Smarter Balanced.

Why does participation matter?

While no single test can give a complete picture of your child's progress, having your child take the statewide tests provides educators and administrators with information about what educational approaches are working and where additional resources are needed. Your child's participation is important to ensure schools and districts receive the targeted resources they need to help all students succeed.

Description of rights

House Bill 2655 permits parents and adult students to annually optout of Oregon's statewide summative tests in English Language Arts and Math by submitting an annual form to the school the student attends. OREGON'S STATE TESTS

- Challenge your child to think critically and apply his or her knowledge to real-world problems
- Go beyond multiple choice and ask your child to explain his or her answers
- Act as a snapshot of your child's progress and may be considered along with other pieces of information to determine your child's academic success
- Help identify schools and districts that need additional supports to ensure more students are meeting higher standards

When will my child take the test?

Your child will be tested once after he or she has completed at least two-thirds of the school year. Your child's school will determine the specific dates your child takes the tests within the statewide testing window.

21st Century Community Learning Center (21CCLC)

After School Program

Nestucca Valley School District and its partners Nestucca Valley Early Learning Center, Community Arts Project, and Food Roots NW will be starting an after school program. The Nestucca Valley 21st Century Community Learning Center (NV21CCLC) will begin Monday November 5, 2018 available to students Pre-K-12. Grades Pre-K-6 will be at Nestucca Valley Elementary School and grades 7-12 will be at Nestucca Valley Jr/Sr High School.

NV21CCLC is made possible by a 21st Century Community Learning Center grant. The program will run Monday through Thursday from 3:00 pm to 5:30 pm on days that students are in attendance in the Nestucca Valley School District during the school year. The program will include opportunities for academics, recreation and enrichment under the supervision of a certified teacher and other competent and caring adults. Bus transportation will be available to transport students from school to a drop off spot where they can be picked up.

Enrollment in NV21CCLC is limited to students who attend a Nestucca Valley School District School, Nestucca Valley Early Learning Center, Nestucca Head Start, and Neskowin Valley School students who live within the Nestucca Valley School District. Enrollment is limited to 100 students Pre-K-6 and 30 students 7-12.

Enrollment applications and information will be available by October 1 on the school district website http://www.nestucca.k12.or.us. The applications will also be available at the school offices at Nestucca Valley Elementary School, Nestucca Jr/Sr High School, Neskowin Valley School, and Nestucca Valley Early Learning Center. To be included in the lottery for available spots applications must be dropped off at Nestucca Valley Elementary School office, Nestucca Valley Jr/Sr High School Office, or the Nestucca Valley School District Office by end of business on OCTOBER 19, 2018. If an application is received after the deadline it will not be included in the lottery and will place at the end of the waiting list.
