

the school website.


It looks right now (we are currently a Moderate Risk county) that spectators will be allowed, however must be in a separate location with separate entrance, exit and restrooms from competitors.



Looking for ways to help your senior look for money to help pay for college next year?

We have a whole list of scholarships on a Canvas page called, "SOAR," that all seniors have been added to so that they can see more detailed information about applying for scholarships and grant funds.



Below are examples of three local scholarships that are coming due in the next month or so, but there are many others listed on the SOAR page.

The award amount is \$1000 scholarships for two graduating seniors from Nestucca High School. Two scholarships will be awarded for the 2021-2022 school year. Any Nestucca High School senior, regardless of GPA, who is a resident of Oregon. The award money will be applied to the receiving student's account for tuition, books, and any other required supplies.

Applications are available in the Nestucca Jr/Sr High School Office.

The application deadline is May 10, 2021.

## Tillamook County Soil and Water Conservation District Scholarship

The economy for Tillamook County comprises mainly of Agriculture, Forest Products, Fishing, and Recreation. For this reason, the Tillamook County Soil and Water Conservation District (TCSWCD) is committed to supporting local students who care about our natural resources and wish to promote conservation, impacting future natural resource decisions. Our goal is to assist college students majoring in the field of agriculture, natural resource science, or a related discipline. The district is pleased to offer three-\$1,500 scholarships for the 2021-2022 school year.

## Scholarship Eligibility

- Students must be a graduate of a Tillamook County high school or a current resident of Tillamook County.
- Scholarships will be awarded to a graduating high school senior or a resident of Tillamook County to be enrolled at any University, College, Junior College or Trade School, working toward an associate, bachelor, graduate degree or trade certification.
- Applicant must be a full-time college student (12 hours or more per quarter or semester equivalent) studying agriculture, natural resource sciences, or a related field (i.e. horticulture, trade).
- It is possible to reapply for the scholarship annually.

## Application Requirements

Tillamook PUD 2021 College Work Program is an excellent opportunity for students to earn money during vacation and summer breaks from college or vocational school. The scholarship is offered each year to one graduating senior who resides in Tillamook PUD's

service area. In the event of a tie, two students may receive the award, at the Board's discretion. The program is open to students pursuing a two-year technical degree, a two or four year college degree.

The TBCC First Class Scholars Program 2021-2022 is a scholarship available to qualified Tillamook County high school or home school graduates that partners with the Oregon Promise to provide funding for tuition, fees and books.

As long as the student maintains his or her eligibility, Tillamook Bay Community College will award \$750 per year for the 2021 and 2022 years or until the student earns his or her first degree, whichever comes first.

Selection for the program will be based on the quality and completeness of the application and essay. We encourage all interested applicants to apply.

There may be a way to still be accepted into the program.


## Career Technical Degree

Graduate from a Tillamook County high school in 2020 Earn a cumulative GPA of 3.0 or better Eligible to enroll in Math 95 and Writing 121


## **TYPES OF ACTS INCLUDE:**

We hope you have been enjoying all of the materials the teachers have been sending home (like pictured!) As we start our hybrid model (in-person OR comprehensive distance learning), we will continue to send these packets home to all of the families who are choosing to stay home the rest of the year. Please continue to meet with your teachers, and let us know how we can support you and your child's learning at home. We have a new handbook for the remainder of the year and COVID guidelines and other policies and procedures meant to keep our staff and community safe. ## FREE CERT BASIC TRAINING Thursdays, April 15 - June 10, 6 – 7 pm

30 hours: Online Units (13 hrs.); Zoom Meetings (9 hrs.); Skills Sessions/Disaster Drill (8 hrs.)

Attendees are expected to complete the online units on their own BEFORE each Zoom meeting. The Zoom meeting will include discussions on the content of each unit as well as examples.

Skills sessions and a disaster drill will include: first aid, cribbing, fire suppression, search and rescue (including how to correctly move an individual). At the end of the drill, participants will receive a CERT bag with a few supplies.

If an individual wants to be an "Active CERT," s/he will complete an application for the Nestucca Rural Fire Protection District and be required to attend monthly CERT meetings/skill sessions.
