

### AGREEMENT BETWEEN THE SOUTH TILLAMOOK COUNTY EMERGENCY VOLUNTEER CORPS (STCEVC) AND

#### **RECIPIENT OF A GMRS RADIO**

The STCEVC is looking to expand its emergency communication network in South Tillamook County. An effective emergency communications network is critical during a disaster. The STCEVC received a grant from NW Oregon Health Preparedness Organization to purchase GMRS handheld radios and distribute them in South Tillamook County. We have focused distribution in the Cloverdale, Hebo, Beaver, Blaine and Sandlake communities.

You have been identified as someone who could assist the STCEVC with its emergency communications network. If you agree to work with the STCEVC on emergency communications, you will receive a handheld GMRS radio.


#### By accepting an STCEVC radio and by signing this document, you agree to the following:

- I agree to take excellent care of the radio by keeping the radio in a safe and secure, but easily
  accessible location, by not changing or damaging the radio in any way and by charging the radio
  correctly as needed.
- 2. I agree to attend a training class on how to operate the radio.
- 3. I agree to participate in monthly 15-minute-long radio drills.
- 4. I understand that the radio is to be used only for training, drills and in a disaster event.
- 5. If a disaster occurs, I will get to safety and turn on my radio.
- 6. I agree that if I move out of Tillamook County, I will return the GMRS radio to the STCEVC.
