Al comenzar el año escolar 2023/24, nos gustaría dar la bienvenida a todos de nuevo. Esperamos tener un año lleno de éxitos. Una de nuestras metas en el Distrito Escolar de Nestucca es mejorar la asistencia. La asistencia regular y puntual es esencial para el proceso educativo. Con el fin de ayudar a los padres / estudiantes para cumplir con esta responsabilidad estamos enviando esta carta con información útil.

Your child may arrive as early as 7:45 School starts at 8:05 at the K-8 Building School starts at 8:00 at Nestucca High School There is a no cost breakfast available.

Nuestro objetivo es tener a todos los estudiantes en la escuela, a tiempo cada día. Sin embargo, nos damos cuenta de que surgen situaciones que requieren que un estudiante esté ausente.

- · Por favor, llame a la escuela por la mañana cuando su hijo esté ausente o llegue tarde. La responsabilidad es tan
- Cuando su estudiante tenga una cita médica por favor traiga una nota a la office para su
  o su expediente. Si las ausencias de su hijo se deben a una enfermedad crónica, le pediremos una nota de su
  médico para confirmar que la asistencia puede verse afectada por el diagnóstico.
- Si su estudiante va a tener una ausencia prolongada, por favor notifíquelo a la oficina con antelación.
   Esto permitirá a los profesores y al personal coordinar con los padres las tareas que puedan necesitar para seguir la instrucción diaria.

El Estatuto de Asistencia Escolar Obligatoria del Estado de Oregon (339.065) permite hasta cinco ausencias en un término de tres meses o no exceder 10 días en los últimos seis meses del año escolar, más se considera excesivo. El Distrito Escolar de Nestucca Valley debe adherirse a estos Estatutos Escolares del Estado de Oregon.

La ley de Oregón obliga a los padres o a las personas que tengan a su cargo a un niño que no haya terminado e l duodécimo grado a matricularlo y mantenerlo en asistencia regular a la escuela. No supervisar a un niño (ORS163.577) es una infracción y puede dar lugar a una citación para comparecer ante un tribunal. Si la escuela determina que un padre no ha inscrito al niño o no lo ha mantenido en asistencia regular, se le dará una notificación por escrito al padre/tutor en control, requiriendo que el padre/tutor en control asista a una reunión con un oficial de la escuela. Si el padre no asiste o no envía al niño a la escuela después de la reunión, la ley estatal y la política del distrito permiten al superintendente o al oficial de absentismo escolar de NVSD emitir una citación para comparecer ante el tribunal. Esta citación podría resultar en una multa según lo determinado por el tribunal.

Nuestra esperanza es mantener a los estudiantes a tiempo, en el buen camino, comprometidos y con éxito. La asistencia es esencial para que esto ocurra. Mantener una comunicación abierta e n t r e los padres y la escuela es vital.

Dear Parents/Guardians,

As the 2023/24 school year begins, we would like to welcome everyone back. We look forward to a successful year. One of our goals at Nestucca School District is to improve attendance. Regular and punctual attendance is essential to the educational process. In order to assist parents/students to meet this responsibility we are sending this letter with helpful information.

Your child may arrive as early as 7:45 School starts at 8:05 at the K-8 Building School starts at 8:00 at Nestucca High School There is a no cost breakfast available.

Our goal is to have every student in school, on time each day. However, we realize that situations do arise that require a student to be absent.

- Please phone the school in the morning when your child is absent or running late. Accountability is so
  important.
- When your student has a medical appointment please bring a note to the office for his
  or her file. If your child's absences are due to chronic illness, then we would request a note from their doctor
  to confirm the attendance could/will be impacted by the diagnosis.
- If your student will have an extended absence please notify the office in advance. This will allow teachers and staff to coordinate with parents regarding assignments they may need to keep on track with the daily instruction.

Oregon's State Compulsory School Attendance Statue (339.065) allows for up to five absences in a term of three months or not to exceed 10 days in the last six months of the school year, more is considered excessive. Nestucca Valley School District must adhere to these Oregon State School Statues.

Oregon's law requires parents or persons in control of a child who has not completed the twelfth grade to enroll the child and maintain the child in regular attendance at school. Failure to supervise a child (ORS163.577) is a violation and may result in a citation to appear in court. If the school determines that a parent has failed to enroll the child or maintain the child in regular attendance, written notification shall be given to the parent/guardian in control, requiring the parent/guardian in control to attend a meeting with a school official. If the parent does not attend or fails to sent the child to school after the meeting, state law and district policy allow the superintendent or NVSD truancy officer to issue a citation to appear in court. This citation could result in fine as determined by the court.

Our hope is to keep students on time, on track, engaged and succeeding. Attendance is essential for these things to occur. Keeping open communication between parents and school is vital.

Nestucca Valley School District Community,

Thank you to all parents, staff, students and supporting community members for your flexibility as we welcomed this one time event, the Cycle Oregon Classic to our K8 campus. More than 1,100 bicycle riders, 70 volunteers and Cycle Oregon staff occupied our campus for two and a half days. This event has brought numerous positive outcomes to our district and community.

- Cycle Oregon donated \$25,000.00 to our school district to continue the development of the K8 Sports Field Complex
- Multiple high school teams, NVSD staff, and parent groups volunteered time, which resulted in their teams, programs and groups receiving thousands of dollars. Thank you to all of those that volunteered
- On their day off from riding, the cyclists went into our towns and enjoyed what our small businesses have to offer, infusing revenue into our community.
- As a district staff, we were able to see the K8 campus in action with thousands of people present and camping. This allowed us insight into how we can organize in an emergency situation and how our facility functioned.
- District teachers were able to utilize these non-student contact days for training on new language arts curriculum. All other staff were not scheduled to work.
- We brought exposure of our small community to people from all over the world with this event. Our student volunteers, and staff were able to foster new partnerships with foundations, business, and supporters of our school work.
- Students have lost no instruction time during this pause. Every year weekdays fall differently, and we continue to serve our students more than five additional days than the state mandates.

I understand there were some concerns during student drop off this morning. There were many moving parts, but we were able to successfully and safely get all students into a fully secure building. During the events entirety, the only Cycle Oregon participants that had been in the building are those with a disability accessing our locker room showers on days that students were not present. Thank you to those that have reached out with your concerns, I appreciate you seeking clarification. Please know every decision we make as an administrative staff is through the lens of safety for our kids and staff first.

Thank you Cycle Oregon and our NVSD family for creating this opportunity for our community!

Through the 21st Century Community Learning Center grant (21stCCLC), during each school year, we will offer homework assistance, academic support, and many Club and enrichment activities to students at the K-8 and high school. We are excited to collaborate with The Sitka

Center for Art and Ecology to provide High School Art workshops, and art activities at the K-8 level. We will extend our Open Campus/Juntos program to include Latinx students and families in middle school and high school. During our 4 week Summer Learning Program each year, participating students in grades K-8th will experience Science exploration and Art creations, while High School students will be offered credit recovery opportunities.




#### **Summer 2023**

Several students at the K-8 school spent part of their summer learning about fossils, dinosaurs, and alternative power sources in the Summer Learning program. In addition to the many activities offered, OMSI provided hands-on exploration of fossils to students in grades 1-4, and experiments in wind, solar, and electric/battery power to students in 5th-8th grade. Several guest speakers from the community also shared their knowledge.

Students traveled to a local fossil site to see fossil beds – and to search for their own fossil and rocks. Sitka Center for Art and Ecology offered a variety of art projects, guest artists, and a chance to produce a musical composition.
