

PROPOSITION NUMBER 1: 2018-19 School Budget

Shall the budget of the Newfane Central School District (the "District") Niagara County, New York, for the fiscal year commencing July 1, 2018 and ending June 30, 2019 in the amount of \$36,385,957 as presented by the Board of Education, be hereby approved and adopted and the required funds therefore be hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in said District to be levied and collected as required by law.

A Message from the Newfane Board of Education President, James Schmitt



On behalf of the Newfane Central School District Board of Education, I would like to extend our thanks to the Newfane

community for your continuing support of our students and the District. We work very closely with the Superintendent and his administrative team to develop a comprehensive fiscal plan that will allow us to continue providing the high quality education and programs for our students, both now and into the future. With the 2018-2019 budget presented in this document, we have tried to provide a balance between the educational programs and activities to be offered to the students and the cost to be supported by state and local taxes.

The 2018-2019 budget has an overall increase of 6.28% over the current year's budget. This represents a significant increase over the last several budgets; however, much of the increase was anticipated due to the recent contractual settlements with our two largest employee unions and with our transportation provider. In addition, this increase will allow the District to maintain the educational programs, activities, and instruction that the community is proud of and has come to expect. The 2018-2019 budget continues to provide for activities such as modified sports and unified sports in our schools, as well as maintain materials, supply and equipment funds for each building. It will also allow us to continue to offer opportunities to welcome the community into our buildings through options like our aquatics and fitness center programs.

Although much of the budget increase for next year will be covered by the reserves (savings) we have accrued specifically for this purpose, the Board is recommending an increase to the tax levy on the revenue side of the budget. While under the New York State Tax Cap legislation the Board could recommend a tax levy increase as high as 4.26%, we are only considering a 3% increase. The impact of this increase will equate to about a \$0.66 increase per \$1000 of assessed value on property in the town (or a \$55 increase to the total tax bill of an average valued home) based on full value.

As a community, we share the responsibility to our youth to provide an educational experience that best prepares them for college or the career of their choice. As a Board, we strive to meet this responsibility on your behalf in a proactive and thoughtful manner that balances the opportunities offered to our students with the financial resources required to achieve those goals. This budget continues to demonstrate the Board's commitment to responsibly balance our District's educational and financial needs.

We continue to look for innovative ideas to support the ever-changing student needs while remaining mindful of the financial burden on the community. Although budgets are put forth and adopted on an annual basis, the budgeting process reflects a consideration of both the past and the future needs of the District over a number of years to reach this educational and financial balance. This can be seen in the enrollment sensitive staffing decisions and facility planning approaches that ensures our resources will remain focused on the students.

Please become informed by reading the information in this newsletter. We encourage all eligible residents to exercise their right to vote on this budget and to elect three representatives to the school board.

Included in the budget of 2018-19 is the first year of a five-year contract for student transportation. The cumulative five-year transportation contract is estimated to be \$12,943,590 for home to school transportation; and \$459,150 for sport or field trips; and \$402,827 for summer special education.

Absentee Ballot Applications

If you are not going to be available to vote in person, you may request an application for an absentee ballot from the District Office, 6048 Godfrey Road, Burt, between the hours of 8:00 a.m. and 4:00 p.m. Monday through Friday. The deadline for requesting an absentee ballot to be mailed to you is May 8, 2018. All ballots must be received by 5 p.m. on May 15, 2018 at the District Office. Who May Vote?

Eligible voters must meet all of the following qualifications:

- 1. Citizen of the United States
- 2. At least 18 years of age or older
- District resident for at least 30 days prior to the vote

No pre-registration is required, although new voters will be asked to provide one form of residency (i.e. driver's license, utility bill). Voters do not need to own property in the District to be eligible to vote.
