Dear Community Members,

We are writing to share updates regarding the District's move towards a hybrid learning plan. An alternative plan for the Pre-K and Elementary School levels has been proposed by NASE in response to the 6 school-level hybrid plans developed by the administration. These plans came out of the School Committee's and NASE's shared desire to offer more robust learning for our students who remain all-remote during the full day hybrid model that had been voted on by the School Committee. The School Committee has received feedback from all sides regarding educators' and the overall community's strong desire to be able to offer a hybrid model that supports both in-person and synchronous remote learning for those for whom it is best while not disrupting fully-remote learning for those who need or prefer it. All community members, from caregivers to teachers to administrators, have strongly voiced the importance of students remaining with their current teachers when possible, as well as a model that is logistically feasible for teachers and administrators.

Whichever model is selected by the School Committee will allow the District to maximize the number of students who remain with their current teacher in our younger grades. However, we know our employees have a variety of individual situations, and not all of them will be able to teach or work inperson, potentially resulting in some students needing to change teachers regardless of the model selected. Under both models, full-time or part-time remote teaching positions created at each grade level would allow families that want to keep their current all-remote schedule to do so. However, the remote classroom, including the peers, the teacher and staff support may be different.

No plan is perfect; each presents different pros and cons. At a special meeting scheduled for this coming Monday, November 9th, at 6:45pm, the School Committee will discuss the two following models, hold public comment so that it can get community feedback, and then vote to either adopt the half-day hybrid plan or maintain the full day hybrid plan for the Pre-K and Elementary grades. Both plans are outlined below. It is due to community input that we are considering an alternative model, and so are seeking community input as to which could best meet the articulated needs of the district. Here are the two models being considered by the School Committee at this time:

Amended Full Day Hybrid Model for Pre-K to 5: Two days of fully in-person learning for hybrid students. Remote-only students can stay with their assigned class or be assigned to a remote-only class to stay on the same remote-only schedule they have had from the start of the school year. Those included below are those who opt to stay with their current class.

NASE's proposed plan for Pre-K to 5: Two half days of fully in-person learning for hybrid students - High risk students receiving in person instruction will maintain their current schedule. Depending on the numbers, additional high risk students may be able to come for four half days. As with the above plan, remote-only students can stay with their assigned class or be assigned to a remote-only classroom to stay on the same remote-only schedule they have had from the start of the school year. Those included below are those who opt to stay with their current class.
