SUBJECT: **New Payroll System – IMPORTANT INFORMATION ABOUT YOUR PAYCHECK**



Effective July 1st, all school districts in Santa Barbara County will be using a new payroll system. We have been preparing for over a year on this transition. As part of the preparation, the district has been working closely with the Santa Barbara County Office of Education to achieve a seamless transition.

It is important with a large scale transition to a new payroll system that employees carefully review and validate their paychecks. Attached is a Quick Reference Guide to our new paycheck stubs.

For your first paycheck (see directly below) of the 2015-16 School Year, we recommend employees follow these proactive steps towards validating paychecks:

- **July 31, 2015:** 12-month employees
- **August 31, 2015:** 11-month employees
- **September 30, 2015:** 10-month employees

1. If you have elected Direct Deposit (ACH Transfer), we ask that you please monitor your bank account on the date of payday to ensure your paycheck has been deposited. **Banking institutions have until midnight the night of payday to deposit funds.**
2. Please review your paycheck stub in detail (see attached Quick Reference).
3. Please immediately notify the Payroll Department in the event of any discrepancies.

Although we don't anticipate any issues, in the event that you have a discrepancy on your paycheck, staff will be available to quickly resolve it. Please contact Nicki Draper with Certificated Payroll at 938-8902 or Michelle Gitchell with Classified Payroll at 938-8903 with any questions.
