Facility conditions: A condition exists that poses an emergency or urgent threat to the health or safety of students of staff including: gas leaks, nonfunctioning heating, ventilation, fire sprinklers, or air conditioning systems; electrical power failure; major sewer line stoppage; major pest or vermin infestation; broken windows or exterior doors or gates that will not lock and that pose a security risk, abatement of hazardous materials, previously undiscovered that pose an immediate threat to students or staff, structural damage creating a hazardous or uninhabitable condition, and any of emergency conditions deemed appropriate by the district. A school restroom has not been cleaned or maintained regularly, is not fully operational, or has not been stocked at all times with toilet paper, soap, and paper towels or functional hand dryers. For a school serving any of grades 6-12, the school has not, at all times, stocked and made available and accessible free of cost, and adequate supply of menstrual products in every womand all-gender restrooms, and in at least on men's restroom The school has not kept all restrooms open during school hours when students are not in classe and has not kept a sufficient number of restrooms open during school hours when students are classes.
