Ann Marie Longo called the meeting to order at 6:45 P.M. Motion by R. Dando, second by J. Romeo, to enter into executive session to discuss legal matters.

Motion by R. Dando, second by J. Romeo, to claim out of executive session at 7:00 P.M.

Stephen Valente gave a presentation on the expenditure budget as well as a review of facilities projects throughout the District.

Mr. Valente reviewed the Board Mission & Goals, budget development timeline, projected 2015-16 tax levy limit, preliminary 2015-16 expenditures and capital planning (short and long term).

Mr. Valente indicated that the current allowable tax levy limit is 1.68%. He reviewed the Tax Freeze Legislation and what this would mean relative to cost savings for the District. He reviewed some positive factors impacting the 2015-16 budget which included TRS & ERS rate reductions, TAN interest rate estimate, health insurance premiums, and collective bargaining agreements. Mr. Valente compared the 2014-15 adopted expenditure budget with the 2015-16 proposed expenditure budget. He explained that the District had done a good job in keeping expenditures down; therefore, currently there is no budget gap. Mr. Valente reviewed some of the areas where the budget was increased for 2015-16 which included technology, mandated Part 154, regulations, high school summer school, STEM/LEGO robotics, and athletics. He reviewed some budget reduction areas which included event supervision, TRS contribution, ERS contribution, and district-wide supplies and materials. Mr. Valente reviewed how the fund balance at this current time and explained why this will change over the next few months.

Mr. Valente reviewed potential use of the Capital Reserve funds. He explained when this fund was established and how it is funded. He reviewed some of the remaining projects for the school year and estimated the funds which would be needed for payment upon completion. Mr. Valente reviewed potential capital reserve expenditures for 2015-2016 as well as potential bond expenditures for 2015-2016 and reviewed current BOND timelines.

Executive Session

Workshop Meeting The Board asked questions relative to Mr. Valente's presentation. Mrs. Longo asked for a preliminary list of savings on capital projects.

The Board reviewed some of the items proposed for both the Capital Reserve Proposition and the Bond vote. The Board agreed to put a resolution on the March 17th agenda for an emergency purchase of a kitchen hood and ceiling replacement at the High School.

Dr. Mulhall, along with Dr. Seinfeld, gave an update on the Mathematics program particularly relative to significant program changes. They reviewed some past presentations which included: Common Core curriculum K-12, associated State Assessments and adoption of Common Core instruction materials. They reviewed the difference between traditional and common core, the Go Math K-6 program and some of its strengths as well as success and challenges. They gave further detail on the implementation of the Common Core Curriculum grades 7&8 as well as Geometry, Algebra 2 and Trigonometry and Pre-Calculus. They spoke on why there was an increased opportunity for all students as well as the successes and challenges.

The audit of the Math program was reviewed as well as the Mathematics Program Open Forum which took place in February. The Board discussed the Math program and asked questions relative to the presentation.

The Board accepted questions and comments from the community, on agenda items, at this time.
