<u>Approval of Agenda</u> – Mr. Lee moved to amend the May 24, 2022, agenda by adding Discussion Item 7 E. *District's Facility Committee Report* (Discussion). Mr. Clark seconded the motion. The motion passed unanimously.

Dr. Schlitz moved to amend the May 24, 2022, agenda by adding Discussion Item 7. F *NSLP Equipment Assistant Grants for Schools* (Action). Mr. Clark seconded the motion. The motion passed unanimously.

<u>Consent Agenda</u> – Mr. Clark moved to approve the consent agenda and minutes from April 26, 2022, May 5, 2022, and May 10, 2022, school board meetings. Dr. Schlitz seconded the motion. The motion passed unanimously.

<u>Recognition/Celebration</u> – Laurie Williams from the Harstine Island Garden Club presented on behalf of the Pioneer School Garden Committee. Ms. Williams shared the success and educational opportunities the students have learned through gardening. The Board took a moment to acknowledge the dedication, hard work and positive influence the Harstine Island Garden Club has brought to Pioneer students, staff and community. May GRIT students and GRIT staff (school secretaries) were announced to the Board of Directors. The District's Top 10% of 8th grade students were introduced.

<u>Business Operations</u> – April budget status reports were reviewed. On May 26, 2022, the 202-2021 Audit Report will be shared with Superintendent Bolender, Fiscal Director Chris Bishop and School Board Directors Dr. Day and Mr. Lee. Mr. Bishop will follow up and share the report in early June.

The District's Facility Committee shared that the surplus Pioneer Virtual Academy (PVA) portable will soon be relocated. Mason County Fire District 5, the new owners of the portable, will be coordinating the moving of the building in early June.

Mr. Lee moved to approve the purchase of a new freezer/fridge for the Elementary School through the National School Lunch Program (NSLP) Equipment Assistance Grants for Schools. Mr. Clark seconded the motion. The motion passed unanimously.
