

Immunizations

Washington State law requires students to have complete (up-to-date) immunizations in order to enter and stay in school, or an exemption on file.

If you believe your child has received all of their immunizations, but you have been given a notice otherwise, please contact your provider to update the records.

*Vaccine doses may be acceptable with fewer than listed depending on when they were given. **Health care provider verification of history of chickenpox disease is also acceptable. Students must get vaccine doses at the correct timeframes to be in compliance with school requirements. Talk to your health care provider or school staff if you have questions.

Medication for Your Child

- **If your child has been prescribed a new medication or now has to take an existing medication at school, please alert your school nurse so that we may keep your child safe and healthy.**
- Authorization to Administer Medication at School
 - This needs to be signed by the provider and a parent/guardian
- A parent or guardian will need to drop off the medication in a new, unopened bottle/package with school staff and proper paperwork.

*Please do NOT send your child to school with any medication that is not prescribed to them and has not been cleared by the school nurse or other staff. This includes over the counter/drug store medications such as tylenol, ibuprofen, cough drops, etc.
