**Ridgemonst Local School District has a renewal on the November 5th ballot.
We have included answers to Frequently Asked Questions for this renewal.**

1) Will this levy renewal increase my taxes?

This is a levy renewal; it is NOT a new tax.



2) What is the background of this levy?

In 2010, voters originally approved a five year 0.75% income tax levy. The levy was renewed in May of 2015 and again in November of 2019. The current levy will expire in December of 2025. The levy on the November 5th, 2024, ballot will RENEW the levy and provide school funding for the next five years (2026-2031).

3) How will the levy renewal dollars be used?

This money is earmarked for the daily operating expenses of our school district. Operating expenses include busing, utilities, maintenance, salary and benefits, and classroom resources for staff and students.

4) How much money is the levy expected to generate?

Ridgemonst Local School District is asking voters to approve a renewal of our five year school levy. Approximately \$600,000 (six hundred thousand) of the districts regular operating budget comes from the 0.75% income tax levy. When one levy expires, citizens must vote to continue providing local school support through levy dollars.

5) What happens if Ridgemonst voters do not support this levy renewal?

State funding provides only a portion of the total dollars needed to operate our public schools. Local funding through school levies makes up the difference. If Ridgemonst voters do not support the 0.75% income tax renewal, our funding over the next five years will be reduced by approximately \$3,000,000 (three million dollars). This could create a deficit in spending to maintain our facilities and pay our staff.

6) Why ask the community for tax dollars?

Over the last 33 years, state funding for public schools has failed to keep pace with the rising costs of educating our students. While there is a new funding plan, it is not 100% funded as of yet and the future of state funding is uncertain. School choice initiatives could further dwindle this funding by redistributing our tax dollars to private schools. Therefore, public schools have been forced to rely more heavily on local sources for funding. This levy is essential in providing operational revenue that has been determined to be necessary to maintain quality programming that our community has come to expect.

7) Why an income tax?

Typically school building and facility projects are paid for through real estate taxes as that is a longer term need and solution. For operating expenses, it is not unusual to seek income tax levies as all who live in the district share in the day to day cost of our school, unlike real estate tax that is only paid by land and homeowners.

Election Day is Tuesday, November 5, 2024.

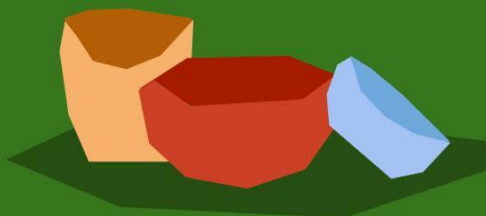

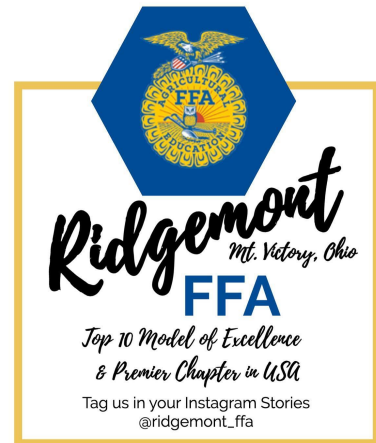
