Riverton School Board Regular Meeting
Riverton Board of Education Office
Thursday, May 16, 2019**

The regular school board meeting of the Board of Education, Unified School District #404, was held on May 16, 2019 at 6:30 P.M. in the Riverton Board of Education Office.
