
## Sachem Schools 2015-2016 Budget




## 2015-2016 Sachem Budget

- The 2015-16 Budget Vote is Tuesday, May 19, 2015
- Governor Cuomo released his 2015-16 Executive Budget. The proposal included an increase in school aid of \$1.06 billion (4.8%) over the 2014-15 levels. This increase is contingent upon the legislature adopting the Governor's education reform agenda which includes new teacher evaluations and a permanent property-tax cap. If the legislature cannot come to an agreement on these proposals, then the Governor has proposed school aid for both 2015-16 and 2016-17 will be held to the amount of school aid districts received in the 2014-15 school year.
- At this time, the Division of Budget has indicated there will not be a release of school aid runs until an agreement is reached, most likely around the start of the state fiscal year, April 1st.
- At 4.8% State Aid increase = \$ 4,449,326
- At 1.7%- State Aid Increase= \$ 983,855
- Therefore, we cannot finalize the 2015-16 Sachem revenue budget at this time, without state aid guidance/ estimates from New York State.
- It is our goal to present the 2015-16 Sachem Budget within Tax Cap limitations.


## Tax Levy Limitations

- In June 2011, the Tax Levy Limit was placed on municipalities.
- The district's unassigned fund balance (savings) is diminished and no longer available to help preserve our programs. As of June 30, 2014, it is \$826,085.
- Being conscious of the tax burden and voting challenges posed by the legislation, our tax levy increase for the past three years are as follows:
  - > 2012-13 = 4.19% tax levy increase
  - > 2013-14 = 3.14% tax levy increase
  - > 2014-15 = 1.88% tax levy increase
  - ➤ 3-year average = 3.07%


#### **Unassigned Fund Balance (Savings)**




# Appropriated, Assigned Fund Balance To Reduce Following Year Tax Levy

- Due to the tax levy limitation, there are restrictions. Additionally, beginning in the 2014-15 year is the Tax Freeze law, with added requirements in 2015-16.
- We must provide an "Efficiency Plan" equal to 1% of the tax levy. We will meet this goal.

In summary, over the past six years we have avoided significant tax increases and restored the majority of programs in the 2014-15 budget.
