It goes back to having the resources at the school so students can use their technology.

Dalia Zimmerman said it has been a great summer. Her son is attending summer school at Anza, this is his third year. She said her son said his teachers are amazing. She thanked those that make summer school happen. Ms. Zimmerman said that people were grateful for having the physical event at Walden. It was great.

Mr. John Sparks said that the conversation about technology access, he said he is in a program right now with a woman that lives in Colorado and in a county that has been publicized as arguably being the worst high speed internet county in the country. Her goal and purpose is to serve that community, the internet access is just one indicator of the lack of services for her county.
