# CURRENT MOU PROCESS IS A CONTINUUM



February/March, 2017

June 30, 2018

**MOU Development/Renewal**

**MOU Review/Evaluation**

- Partnership initiation happens throughout the school year
- New partners are asked to fill in blank sections of the MOU
- Terms for evaluation of the program are decided upon and entered under “Performance Standards”
- MOU renewals require a review of existing performance standards before submission for approval

# CURRENT MOU EVALUATION PROCESS



## Performance Standards/Outcome Metrics entered in a current MOU under Article 7:

**7. Agency performance at the end of the term of this Memorandum of Understanding will be measured by the Agency's compliance with the following performance standards:**

An increase in attendance of 2-5 % among all participating students

An overall decrease in the number of discipline referrals among participating students

- District staff requests an outcomes report from the agency and meets to discuss whether performance standard goals have been met.
- Based on results, the district decides whether to continue the partnership.
- Results are recorded in the current district evaluation form: "MOU Performance Standard Report"

# GIRL SCOUTS OF EASTERN MISSOURI



Language taken directly from the MOU

“This partnership is formed so together we can provide students the array of leadership development programming that Girl Scouts offers. These programs include the Community Troop Program and Outreach Program. These programs focus on anti-violence and anti-bullying education; the troop experience through the community troop program and skill building and career exploration through STEM, Money Management and Health programs.”

### **7. Performance Standards: Agency performance at the end of the term of this MOU will be measured by:**

- (a) Pre- and post-surveys with teachers and counselors will be conducted for each program and outcomes provided.

## PERFORMANCE STANDARD REPORT



### Performance Standard 1: Girl Scouts Programming

Status: The Girl Scouts delivered the Community Troop program to all articulated schools as promised. Based on feedback from selected schools (and surveys), the anti-violence/anti-bullying education, skill building, money management and health programs were all delivered in a satisfactory manner within the schools. This evaluation is based on outputs, not outcomes and the MOU for 17-18 reflects more of a focus on outcomes.

# PARTNERSHIPS BY THE NUMBERS



- Over 60 **NON-PROFIT** school based partners (with MOUs)\*
- Over 70 campuses are being served by a non-profit partner

\*This number represents non-profit partners who have a sustained relationship with a school and require an MOU. Generally speaking, one-time engagements with a non-profit partner such as large group presentations do not require an MOU and thus are not captured in this number.

## Continuous Improvement Process


### **Quantitative Indicators of Effective Program Implementation:**

Agencies list the output/outcome goals as defined by the agency and informed by conversations with school staff.

### **Qualitative Indicators of a High Quality Partnership:**

- Strength of Agency's Internal Performance Measurement Systems
- Strength of Information Dissemination/Partnership Communication
- Strength of Relationships with students and/or school staff
- Partner/Agency Adaptability to School Culture
