E-Rate Definition

Program created in 1996 which provides discounts for schools & libraries in:

- ▶ Telecommunications
- ▶ Internet access
- ▶ Internal connections
- ▶ Basic maintenance of internal connections

- ▶ Discounts are based on the free/reduced lunch percentage
- ▶ Requests for Proposals (RFPs) are posted
 - Bids are received & reviewed
 - Vendor is selected
 - Application is submitted
 - Schools wait for approval

E-Rate Historical Initiatives

- ▶ Installed current network – both wide area network & local area network (WAN & LAN) in 2001
- ▶ Local telephone service *
- ▶ Internet access for District *
- ▶ Cell phones *
- ▶ Maintenance on network and telephone equipment **
- ▶ Cabling (both new wiring and repair) **

Awards vs Disbursements

- Awarded Funds are “Budgeted Amounts” only
 - Disbursements are based on actual invoice amounts
 - Total disbursements will be less than awarded funds

E-Rate Status Update (since 2007)

- Funding awarded through 12/31/2013 – \$34.1M
 - 2007 -- \$8.4M  *
 - 2008 -- \$2.8M
 - 2009 -- \$5.3M
 - 2010 -- \$4.6M
 - 2011 -- \$1.3M  **
 - 2012 -- \$10.2M
 - 2013 -- \$1.4M (P1)
- Funding still under Review by SLD
 - 2013 -- \$3.3M (P2)

* Money held up due to E-Rate audit

** Money released after “clean” audit

Current Status & Initiatives

- 2014 Funding Applications
 - Local phone service
 - Cell phone service
 - Internet access (RFP)
 - Internal connections (RFP)
 - Cabling (break/fix)
 - Network maintenance
 - Upgrade to current network (remaining 18 schools)

E-Rate Budget Savings

- ▶ Internet Access
 - RFP shows reduction of 35%
- ▶ Internal Access
 - RFP shows reduction of 25%
