Retention Challenge: Overview





- ▶ St. Louis Public Schools must comply with the SLPS Promotion and Retention Policy – Policy 5123 revised June 4, 2012
- ▶ St. Louis Public School District is subject to Section 167.645 commonly referred to as Senate Bill 319
- ▶ St. Louis Public School District is subject to Missouri Statute 162.1100 as a result of its governance by the Special Administrative Board, thus is considered a Transitional School District



Retention Challenge: Overview

- ▶ **Large number of students attending summer school:** We have a large number of students who are attending summer school who are not making progress while attending summer school.
- ▶ **Students behind in reading and math:** We have a large number of students who are behind at all grade levels as indicated by the results of our current MAP scores.
- ▶ **Transformation plan will generate progress:** With the release of the transformation plan, we will be aligning our academic approach to the goals of this plan. This implementation will take us through the course of this school year before we will see tangible results.

Currently we are improving those practices to ensure we are meeting the needs of all students.</p>	<p>For students who have been flagged as a retention risk, we have identified three tiers of strategic intervention that will allow us to support students based on their individual academic needs for this school year.</p>	<p>Over the next 9 months we are creating a three phased approach that will allow us to monitor the progress of students, communicate with parents effectively, hold each other accountable for student outcomes, and strengthen our retention policy.</p>	<p>Currently we are analyzing the data to ensure that the retention policy is strong, students who were recommended for retention receive the services they need, and we update our retention policy and approach for the 2015-2016 school year.</p>
