Summary

- ◀ Increase in the use of manipulatives and differentiated instruction
- ◀ DOK level 1 and 2 were predominant
- ◀ Improved level of implementation of project-based curriculum and parent /community participation
- ◀ Increase in lesson objectives reflecting appropriate GLEs and use of related technology



Summary

- ↳ 6,739 students enrolled with an average daily attendance of 87%
- ↳ Approximately 2,100 students qualified for the perfect attendance incentive
- ↳ 476 staff were employed and 99.7% were retained (only one SPED position was reduced)
- ↳ All elementary and middle schools sponsored an Academic Fair where students, parents and community members engaged in project-based learning
- ↳ 30 students graduated from high school as a result of ACE
