The district provided opportunities for stakeholders to engage meaningfully in the development of the strategies used in this plan to address the academic impact of lost instructional time and reduce the severity of the impact caused by COVID-19. Stakeholders who participated include: parents, students, teachers, principals, administrators, other school personnel, board members, District English Language Advisory Committee (DELAC), District Curriculum and Technology Committee (DCTC), School Site Council (SSC), LCAP Advisory Committee and local bargaining units of the LEA. Stakeholder input was gathered in a variety of ways: student, parent, staff surveys; committee meetings; family discussion forums; mass phone calls/emails to families inviting them to participate in discussions and provide feedback.

Stakeholders identified the challenges including students who did not fully engage while on distance learning and the continued need for additional time to support struggling students to accelerate their learning. Families shared about the challenges they faced as they navigated through this trying time and the stress experienced by their children. Many expressed their concerns over their children's feelings of isolation. Several parents didn't feel adequate in supporting their child during distance learning. Teachers noticed that student anxiety was more prevalent and identified more students in need of supplemental instruction to help them move forward for successful grade level learning. Administration shared how vital contact tracing is to help protect students as they returned to in-person instruction; however, it is time intensive.

### A description of how the development of the plan was influenced by community input.

As a result of community engagement and input, ESSER III funds will be used to focus district efforts to increase access to Tier 2 and Tier 3 supports. Additional staff will help to address the academic impact of lost instructional time.

To further address barriers to learning, the district will focus on strengthening its Positive Behavior Intervention and Support (PBIS) structures. The district continues to partner with community agencies/services to help a child and their family meet identified needs such as: county mental health, Jessica's House (support for children, teens and their families grieving a death), Community Hospice, Stanislaus BHRS (Behavior, Health and Recovery Services), Beyond the Walls (counseling services for students with incarcerated parents), and Center for Human Services (a local nonprofit serving youth and families in Stanislaus County through prevention, education, intervention, shelter, and counseling). Funds will be used to provide additional health services to provide for safe, in person learning and to address the mental health and well-being of children.

# **ESSER III Expenditure Plan Instructions**

#### Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a
    distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;
