Board President Chad Neal called the meeting to order at 6:00 PM and asked Randy Johnson to open the meeting up with a prayer. Visitors present, Lindsay Dean, Meleina Womack, Emma Alcorn, Phillip Alcorn, Branda Redar, Joey Dawson, Christian Merritt, Shawn Treadway. Joli Maroney, Stacey Sheer, and Brandon Mitchell.

1. Public Forum: Shawn Treadway was introduced as our new AG teacher. He gave a brief background on who he is and where he is from. Joey Dawson and Christian Merritt with Live Oak Public Finance, LLC gave a presentation on taking advantage of passing a bond with a discount to the taxpayers due to the solar farms absorbing a big portion of that tax burden.
2. Administration reports: Joli Maroney reported on the STAR results and changes. Mr. Stickles reported that the corner lot has been finalized. The empty houses for sale have not had any bids. Progress is being made in the Gym. The new concrete entryway by the ag shop has been completed. Mr. Stickles updated the board on the legislation going on in Austin.  - VII. Mason Littrell made a motion to accept Hector's bid to remodel the gym lobby. Mark Sustaire seconded. Passed 5-0
 - VIII. Mark Sustaire made a motion to accept resignations of Casey Riddle, Brett Myers, and Joli Maroney. Mason Littrell seconded. passed unanimously
