Booster Club

A. Emma Alcorn addressed the board about making some changes and upgrades in the concession stand. They would like to use some of the booster funds to purchase a new grill, sink, refrigerator, deep fryers, and an ice cream machine. Mark Sustaire requested a copy of what the Booster Club brought in to see where the funds that they are raising is coming from. Lindsay Dean said she could bring that information for the next board meeting.

2. School Lunch Program

A. Susan Smith introduced Diana McGregor from Region 8 to the school board to discuss changing the school lunch program. Susan would like to switch to the CEP Program which will give free breakfast and lunch to all students. By going with this program we would have 65% of our kids reimbursed at \$4.25 and the other 34% would be reimbursed at a paid rate of .42 per tray. Diana McGregor showed an estimator that showed where using this program will potentially make all our meals free depending on participation. Diana also reported that other similar schools went with this program and had positive results.

3. District Reports

- A. Stacie Shearer reported that the school should have results for the STARR test by the end of the school year. All field trips went well. Preparations are being made for summer school. The school is ordering new science textbooks.
- B. Jarret Wilson reported that the parent sponsored field day went really well. Mr. Wilson gave a report of all the High School and Jr. High Valedictorian and Salutatorian. Mr. Wilson reported that he is looking at Coach Parker's replacement, but other than that all positions have been filled.
