

101 – Zachary Griggy

Given the boundaries of the San Rafael Elementary School and High School districts this map aims to ensure all board trustees represent at least some portion of the elementary school district while avoiding pairing incumbents while trying to follow geographic boundaries ex. Gallinas Creek or ridgelines be as compact as possible and minimize the splitting of neighborhoods. The first district includes most of the Santa Margarita Valley and neighborhoods around Terra Linda High School and the Civic Center. Trustee Greg Knell resides in District 1. The second district, in which Trustee Rachel Kertz resides, includes Lucas Valley, Marinwood and Santa Venetia. The third district includes much of western San Rafael including much of the downtown. Trustee Linda Jackson lives in District 3. The fourth district, home to Trustee Natu Tuatagaloa, includes most of eastern San Rafael, extending from Lincoln Ave to Peacock Gap. The fifth district includes much of southern San Rafael, including the Canal as well as portions of Larkspur and San Quentin Village. Trustee Maika Llorens Gulati resides in District 5.

102 – Zachary Griggy

This map, similar to my first, tries to address the differences between the boundaries of the San Rafael High School and Elementary School districts. This second map is very similar to my first in that districts 3, 4 & 5 remain largely unchanged. In this case, the map tries to maximize the political influence of the elementary school district residents while also remaining compact and following geographic boundaries. Four districts include significant amounts of population that reside within the Elementary School District, increasing the likelihood that the map will elect trustees accountable to the elementary school district. District 1 includes much of the Santa Margarita Valley and Lucas Valley. Trustees Greg Knell and Rachel Kertz are paired in District 1. District 2, an open seat, includes the neighborhoods around Santa Venetia and Los Ranchitos. Districts 3, 4 and 5 are largely left unchanged from my previous submission (Map 101).

103 – Cassandra Lane

This proposed plan maintains the integrity of the Latino population in the Canal, incorporates the Baypoint neighborhood with the Glenwood / Loch Lomond area, and mixes the Dixie district into districts 3 and 5.

104 – Jon Marker

I think there needs to be a little tweaking on this to smooth the two northern districts and number 4, but this has the benefit of having a higher Latinx population % in number 5 than the three maps drawn by the demographer. I would be happy to have anyone use this as a base to iterate from.
