Sierra Expeditionary Learning School (SELS) opened in the fall of 2010 as an independent public charter school serving 64 K-5 students. Over the first three years, SELS expanded and now serves 212 students in grades K-8. SELS offers a small school environment (class sizes from 22-25) dedicated to academic excellence, diversity, and the building of character and community. SELS is a school of choice and uses a lottery-based enrollment process. Besides running standard mathematics and literacy programs, SELS, as a member of the EL Education network of schools, focuses curriculum on thematic-based expeditions, character education, fieldwork, and the building of school-wide community and culture.

That said, we continue our efforts to best support all our school populations by continuing to fund the extra support teacher hours, continuing a part time Instructional Coach added in '18-19, and adjusting programming as needs arise. Efforts are spent regularly to reduce the achievement gap between various demographic groups.

LCAP Highlights

Funding increases for academic and social-emotional support continues, primarily targeting sub-group populations: Support Teachers at K-1 and middle school; additional hours for ELD Coordinator and Counselor; elementary math RTI; and increased Reading Specialist support. Additionally, classroom teachers improved their strategies/protocols to broaden delivery and student engagement, and will be additionally supported by a two-day per week Instructional Coach. 2021-22 will continue with the same goals as they have demonstrated effectiveness.

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [EC] 52064(e)(1)). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. Local educational agencies (LEAs) should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
