#### IV. <u>COMMUNICATIONS</u>

- A. <u>Oral Communications</u>
  - 1. <u>Audience</u>
    - Mr. Christopher Bourke, Teacher, addressed the Board in regards to the application for approval for exemption from the required expenditures for classroom teachers' salaries. He said he would normally make a fuss about this; but with the upcoming increased to STRS this will take care of meeting the 55% requirement. He pointed out a discrepancy in the report that teachers are overpaid and that special services contracts and independent contracts count as part of the requirements and this was not so. He did thank staff for doing a much better job to meet the 55% requirement.
    - Andria Brinson, President of Chamber, parent of children in the district and mother of two children with Autism. She said she was one of the candidates running for the open board seat. She was at the meeting to talk about invoking change. She commended all those who were applied for the open board seat; but she'd like to see someone who has never served before. She said she was a Special Education specialist and this is near and dear to her. Therefore, she'd like to see someone chosen with new ideas and someone who is innovative. Whether she winds or not; she still wants to see a change on the Board.
    - Erica Avila, parent, addressed the Board to support and encourage the Board to choose Andria Brinson for the open Board seat. She also asked the Board not to choose someone who has served on the board; but someone like Ms. Brinson who has the best interest of children as a priority and with the Special Education background, she is the best candidate. She could save the district thousands of dollars as currently the district has seven lawsuits and Andria would be a blessing to the district.

• Mrs. Maria Sanchez from the PANESC Parent Support Group also addressed the Board to voice her support for Andria Brinson as a Board member and she said they don't want to see someone who has served on the Board to be chosen.

# 4. <u>Maintenance, Operations, Transportation, Safety and Facilities</u>

- a. <u>Main Street Construction Update</u>
  - Masonry block is 100% completed
  - Building C: currently working on the fabrication of the steel and masonry for that building. I
  - Project is on time and budget.
  - School site meetings with Principals on traffic safety circulation while construction is taking place.
- b. <u>Master Facilities Plan Update</u>: They are in process of updating the plan.
- c. <u>Districtwide Solar Project is on track.</u> Each school will have solar panels with the exception of CEC. Our district will be the only one in South County to have all their schools on solar panels.
- 5. <u>Board Member comments</u>
  - Trustee Fernandez congratulated the Students of the Month as said they are the role models for all students to follow. He also

congratulated the Employees of the Month. He asked all those Veterans in the audience to stand up and be recognized in Honor of Veteran's Day. Mr. Bourke was the only one in the audience and he was thanked for his service. Trustee Fernandez also congratulated Soledad High School's NJROTC for their wins at the competition in Sacramento; even though they were the smallest school, they did extremely well. He said they are not recognized enough. They travel Over 200 students travel a lot for competitions and events. They will also be participating at the Veteran's Day Parade in Salinas next Saturday. Their next competition will be in Reno Nevada and Nationals in Florida.

- Trustee Fernandez also congratulated the Soledad High Football Team as they actually won the MTLA Title. He also commended Main Street for the new updated school Trojan Logo.
- Trustee Galvan also commended the NJROTC for their dedication; they get up very early in the morning for training rain or shine. He also thanked Mr. Bourke for service to our country. Trustee Galvan congratulated the Students of the Month and the Employees of the Month. He said we have great students because of the great staff we have. He also wished good luck to the candidates who applied for the open board seat and were in the audience: Mr. Barrera, Ms. Brinson and Mrs. Pantoja.
- Trustee Perez-Aguilera also dittoed the previous congratulatory comments for the employees and students of the month. She also shared what she learned from the Masters in Governance Board trainings: That the role of the Board members is to try and govern at the same time they need to comply with the law. California has the lowest funding per pupil in education. Yes our teachers are not getting paid what they should and as Board they take that in consideration. They do the best they can despite inadequate funding. It's hard work despite lack of resources and they appreciate what everyone does. She said these have been the most positive board meetings. Some are hard because as a Board, they have to deliver bad news. Hearing Mr. Bourke say that he sees they are trying, means a lot to them. She thanked staff for their hard work. She wished good luck for those who are applying for board. They have to look at the big picture and make decisions as a whole not as individuals.
- President Massa: Seconded everything said by her colleagues. She also congratulated Trustee Perez-Aguilera for completing her Masters in Governance Courses.

- Andria Brinson, announced the PANESC Conference taking place on Saturday, November 11 8a.m. – 2:30 p.m. at Soledad High. She invited Board and anyone else interested to attend. It's a conference for parents with special needs children where they will obtain medical, legal, educational information. There will also be resource tables. Ms. Brinson asked the Board if they had time to stop by and if they wanted to address the group, they were welcome to.

Comments by the Board:

- Under the Teacher Missasignments, Trustee Perez-Aguilera asked how many did we have. Ms. Cline, Executive Director of H.R. said we had none as Mrs. Munguia; our Personnel Coordinator does an amazing job in certification of the teachers.
- Trustee Perez-Aguilera asked about what we were doing to improve under the State's Academic Standards. Dr. Witwer said that we are ahead because we have bought the New Generation Curriculum. It's a matter of implementation and time to collaborate and pull out the exploration materials. Other districts have not adopted the curriculum yet. Mr. Vanoli, Superintendent commented that our focus is in Math and it usually takes three years to see any improvement.
- Under Priority 3 Parent Involvement, Trustee Perez-Aguilera asked if we had seen any improvement. Yes, there has been. They moved to a different site for the meetings and also provided food.
- Priority 6 School Climate: survey data from students and parents that 97% of them feel safe and 3% did not. All Trustees were concerned with the 3% that did not feel safe and asked if they could identify those students and why they did not feel safe. They all wanted more information on why this 3% did not feel safe in order to fix it and at what site(s). Dr. Witwer said that we are going to give the Healthy Kids Survey and we can also include our counselors in the conversation to try to get the answer.
