A. <u>Oral Communications</u>

1. <u>Audience</u>

Mrs. Josefina Munoz, parent of a Special Education student, addressed the Board regarding information that she was given at her daughter's IEP. At the IEP she was notified that next year, her daughter would be in the same Math class as regular education students and that it was not an option. As part of a group of parents of children with special needs, she was concerned as there are students with autism that cannot tolerate loud noises or bright lights. She questioned why the change and Mr. Moreno, Special Education Coordinator, happened to be at that IEP and his answer was that at the last district they had inclusion program and it worked out well. Mrs. Munoz was also concerned about regular education teachers not having the special training they need for inclusion of special education student. Mr. Vanoli gave Mrs. Munoz his contact card and asked that she call him to schedule a meeting to address her concerns.

Introduction

School Site Solutions, Inc., in conjunction with Belli Architectural Group and SchoolWorks, Inc., is pleased to have been selected to develop a Five-Year Facilities Master Plan.

This plan will provide a guideline for the District for planning, designing and constructing new school facilities and modernizing existing facilities to meet the educational programs of the District over the next five years.

Objectives of the Plan

To comply with Board of Education policies:

- Board Policy 7000: Importance of Healthful, Safe and Adequate Facilities
- Board Policy 7110: Why is a Facilities Master Plan important?

Data-Gathering Methodology

Major Facility Themes


- Inequity between the newer elementary schools and the older elementary schools is an important issue.
- Safety and security needs are priorities.
- Technology in the classroom and in core facilities will be a continuing need.
- Infrastructure and major system improvements are needed at all schools.
- Replacement of portable classrooms with permanent buildings continues to be a need.
- Soledad High School facility needs include additional classroom capacity, science labs, campus exterior improvements, track and field and agriculture program upgrades and/or relocation.

Major Findings

- Enrollment trends and projections
- School capacities
- Projected new residential development and students projected to be generated
- Prioritizing potential projects for Measure G program
- Estimated cost of 2 new elementary schools and new classrooms at Soledad High School to serve the Miramonte development is approximately \$54.5 million
- The total estimated cost for Tier 1 modernization projects (potential high priority) ranges from \$99 million to \$117 million, depending on the options of either modernization or a new replacement school at Gabilan ES
- Combined Tier 1 new construction and modernization costs are estimated at between \$153 million and \$172 million over the next ten years

Recommendations

- Address the inequity between the older and newer schools by building a new replacement school at Gabilan Elementary and replacing all portable classrooms with permanent buildings at San Vicente.
- Continue to foster transparency and accountability in the facilities program.
- Pursue all available funding, including future State funding, local bonds, developer fees and other assessment districts, joint projects with other agencies.
- Prioritize projects in order to develop and approve a Measure G project list.
- Continue to work with the City of Soledad and the developers to establish sufficient funding for the construction of new elementary schools and high school facilities that will be needed to house students from proposed new developments.
- Use the Facilities Master Plan to initiate further refinement of projects.
- Update the Facilities Master Plan every other year, or as needed.
- Update State School Facility Program eligibility every year.
