NOTICE IS HEREBY GIVEN that a Public Budget Hearing for the inhabitants of the South Colonie Central School District, Town of Colonie, Albany County, qualified to vote at school meetings in said District will be held on **Tuesday**, **May 10**, **2022**, at 7:00 pm for the discussion of the expenditure of funds and the proposed budget for the 2022-2023 school year and the transaction of such business as is authorized by New York State Education Law.

PROPOSITION #1 – ANNUAL OPERATING BUDGET

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the South Colonie Central School District, Albany County, New York be authorized to expend sums as set forth in the annual operating budget for the 2022-2023 school year and to levy the necessary tax therefor.

PROPOSITION #2 – SCHOOL BUS PURCHASE

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the South Colonie Central School District, Albany County, New York, is hereby authorized to purchase and expend therefore, including costs incidental thereto and the financing thereof, an amount not to exceed the estimated maximum cost of one million one hundred fifty eight thousand dollars (\$1,158,000.00), and for a term not to exceed five (5) years, the following motor vehicles: six (6) 66-passenger buses, one (1) 24-passenger wheelchair bus, two (2) 16-passenger buses, and one (2) 6-passenger vehicles/buses; and that such sum, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said school district and collected in annual installments as provided by Section 416 of the New York State Education Law; and that in anticipation of such tax, obligations of said school district shall be issued.

NOTICE IS FURTHER GIVEN that the aforesaid proposition will appear on the ballot for the voting machines used at such Annual District Meeting in the following abbreviated form:

Abbreviated Form of Proposition

Shall the proposition set forth in the notice of this meeting authorizing the purchase of school buses, at an estimated cost not to exceed \$1,158,000.00; and providing that such sum, or so much thereof as shall be necessary, shall be raised by a tax levy to be collected in annual installments, with District obligations to be issued in anticipation thereof, be approved?

PROPOSITION #3 – REAL PROPERTY PURCHASE

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the South Colonie Central School District be authorized to purchase approximately 14 acres of real property located at 1015 Watervliet Shaker Road, Colonie, New York for the construction of a bus garage for the District's bus fleet, bus parking and storage for the District's operation and maintenance equipment and other school district improvements at a maximum estimated cost of one million nine hundred thousand dollars (\$1,900,000.00) with said amount or so much as may be necessary to be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, obligations of said School District to be issued for a period not to exceed thirty years, be approved.

SEQRA DETERMINATION: The School District has acted as lead agency under the State Environmental Quality Review Act regulations of the State of New York, The capital project herein authorized has been determined to be an "Unlisted Action" pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act ("SEQRA"), the implementation of which as proposed, it has been determined will not result in any significant environmental impacts. The SEQRA compliance materials are on file in the Office of the District Clerk and are available for public inspection during regular business hours by appointment. Site specific SEQRA review will be completed by the municipality where the real property is located at the time that the School District submits its site plan for the project.

NOTICE IS FURTHER GIVEN that the aforesaid proposition will appear on the ballot for the voting machines used at such Annual District Meeting in the following abbreviated form: **Abbreviated Form of Proposition**

Shall the proposition set forth in the notice of this meeting authorizing the purchase of approximately 14 acres of real property in Colonie, New York, at an estimated cost not to exceed \$1,900,000.00; and providing that such sum, or so much thereof as shall be necessary, shall be raised by a tax levy to be collected in annual installments, with District obligations to be issued in anticipation thereof, be approved?

NOTICE IS FURTHER GIVEN that absentee ballots shall be made available in accordance with the provisions of Section 2018-a of the New York State Education Law and

that applications for such absentee ballots may be applied for at the office of the District Clerk, 102 Loralee Drive, Albany, New York 12205. Member for five (5) year term expiring June 30, 2027 to succeed Rose Gigliello seat. Member for five (5) year term expiring June 30, 2027 to succeed Michael Keane seat.

Each vacancy is a separate and specific office and a separate petition is required to nominate a candidate to each separate office. Each petition must be directed to the District Clerk, must be signed by at least **twenty-six** (26) qualified voters of the District (at least 25 signatures or equal to two percent of the voters who voted in the previous annual election, whichever is greater) with their addresses and must state the name and residence of the candidate and must describe the specific vacancy for which the candidate is nominated, including at least the length of the term of office and the name of the last incumbent.

Voting on Proposition #1, Annual Operating Budget;; and election of two member of the Board of Education will be held at Forest Park Elementary School, Roessleville Elementary School, Saddlewood Elementary School, Shaker Road Elementary School, and Veeder Elementary School on Tuesday, May 17, 2022, between the hours of 11:00 am and 9:00 pm. Qualified voters may cast a ballot at any of the polling places.
