BEGINNING at a point where the east line of Sec. 23, Twp. 7 N, R 42 EBM, intersects the middle of the main channel of the Teton River, which is also a point on the Madison-Fremont County line; thence south approximately 2. miles to the SE corner of Sec. 35, Twp. 7 N, R 42 EBM; thence east 1 mile to the NE corner of Sec. 1, Twp. 6 N, R 42 EBM; thence south 3 miles to the SE corner of Sec. 13; thence west 1 mile; thence north 1 mile to the NW corner of Sec. 13, Twp. 6 N, R 42 EBM; thence west 2 miles to the SW corner of Sec. 10; thence south 3 miles to the SE corner of Sec. 28, Twp. 6 N, R 42 EBM; thence west 8 miles to the SW corner of Sec. 29, Twp. 6 N, R 41 EBM; thence north 1 mile; thence west 1 mile; thence south 1 mile to the SE corner of Sec. 25, Twp. 6 N, R 40 EBM; thence west 2 miles to the SW corner of Sec. 26; thence north 2 miles to the NW corner of Sec. 23, Twp. 6 N, R 40 EBM; thence west 1 mile to the SW corner of Sec. 15; thence north 1 mile to the NW corner of Sec. 15; thence west 3 miles to the SW corner of Sec. 7, Twp. 6 N, R 40 EBM; thence north 1. miles to the NE corner of the SE. of Sec. 1, Twp. 6 N, R 39 EBM; thence west 1 mile to the SW corner of the NW. of said Sec. 1; thence north . mile to the NE corner of Sec. 2, Twp. 6 N, R 39 EBM; thence west approximately 2 miles to the North Fork of the Snake River, and following the meanderings of the river downstream in a southwesterly direction approximately 6 miles to the section line between Sec. 19 & 30, Twp. 6 N, R 39 EBM; thence west 3-3/4 miles, more or less, to the Jefferson County line; thence north along the county line 7 miles to the Madison-Fremont County line at the NW corner of Sec. 22, Twp. 7 N, R 38 EBM, and continuing north 3 miles on the Fremont-Jefferson County line to the NW corner of Sec. 3, said township and range; thence west along the section line 6. miles to the SW corner of the SE . of Sec. 33, Twp. 8 N, R 37 EBM; thence north 2 miles to the NW corner of the NE . of Sec. 28; thence east 9. miles along the section lines to the NE corner of Sec. 25, Twp. 8 N, R 38 EBM; thence south 2 miles to the SE corner of Sec. 36, said township and range; thence east 1-3/4 miles to the NE corner of the NW . of the NE . of Sec. 5, Twp. 7 N, R 39 EBM; thence south 1 mile to the SE corner of the SW . of the SE . of said Sec. 5; thence east 3/4 mile to the NE corner of the NW . of Sec. 9, said township and range; thence south 1 mile to the SW corner of the SE . of said Sec. 9; thence east . mile to the NE corner of Sec. 16, said township and range; thence south . mile to the east . corner of said Sec. 16; thence east . mile to the middle of Sec. 15, said township and range; thence south . mile to the Madison-Fremont north county line and continuing south into Madison County approximately 2. miles to the middle of the main channel of the Henrys Fork of the Snake River; thence following the meanderings of said river upstream in a northeasterly direction approximately . mile to the Madison-Fremont north county line and continuing into Fremont County along the meanderings of the river in a northeasterly direction approximately 6 miles to the east boundary line of Sec. 16, Twp. 7 N, R 40 EBM; thence south approximately 2. miles to the SW corner of the NW . of Sec. 27, said township and range; thence east . mile to the NE corner of the SW . of said Sec. 27; thence south . mile to the Madison-Fremont north county line at the SE corner of the SW . of said Sec. 27; thence east along the county line 1 mile to the NE corner of the NW . of Sec. 35, Twp. 7 N, R 40 EBM; thence south 1. miles to the middle of Sec. 2, Twp. 6 N, R 40

EBM; thence east 1 mile to the middle of Sec. 1, said township and range; thence south . mile to the SW corner of the SE . of said Sec. 1; thence east 3 miles along the section line to the SE corner of the SW . of Sec. 4, Twp. 6 N, R 41 EBM; thence north 1. Miles to the middle of Sec. 33, Twp. 7 N, R 41 EBM; thence east . mile to the NE corner of the SE . of Sec. 33, Twp. 7 N, R 41 EBM; thence north approximately 1. Miles to the middle of the main channel of the Teton River at approximately the SW corner of Sec. 22; thence following the meanderings of the Teton River upstream approximately 5 miles to a point where the Teton River meets Madison-Fremont County north line approximately at the SW corner of Sec. 30, Twp. 7 N, R 42 EBM; thence following the meanderings of the middle of the main channel of the Teton River and Madison-Fremont north county line approximately 5 miles in a northeasterly direction to the point where the east line of Sec. 23, Twp. 7 N, R 42 EBM, intersects the middle of the main channel of the Teton River, the point of beginning.
