# Planning and Discussion Reports:

Beth Moore - One of my responsibilities is to meet with teachers from kindergarten through eighth grade for half-day data meetings. But those meetings aren't just about the data, it's about what they do to move that data, like Katherine shared earlier. And so it's just been a really great opportunity to look at the report cards that we looked at last month, look at their building report cards, look at how each grade level in such an area contributes to that, review gap closing and what they can do to move the needle on that and ultimately grow students. We look at MAPS reports, again, with the whole feel of what data is useful for them to use in their everyday classes. We also are able to look at whatever universal screener they have chosen, DIBELS for the younger grades and MAPS in the upper grades, and then also some of the state testing that was... The state has built a site where they're able to take mock assessments, and the high school typically uses that as well, as well as actually 4-12 have that ability. So we look at that, and the system has also made it nice so that they can look at past scores for the students that sit in their classroom. So it's an opportunity to take a half day and work with teachers K - 8 on that.

Also curriculum, lots of new curriculum, as you know, we used a lot of ESSER money to beef that up. And so we've spent a lot of the time looking at the successes, struggles, and what their needs are, and how to move forward to make that happen. The high school is not a big negotiation for them, but I'll be over on the 21st. It's been a whole day in case they want to discuss those things as well. That's been great, but that's seventeen half days. I feel like I'm glad

that was negotiated. It is really a great opportunity to meet with all the people. Like I said, it's great to share that data with you guys and the principals, but until it gets to the teacher level, we really can't get moving on that. So it's a good opportunity to do that. I also wanted to share that our third graders do their fall testing next week. So that's happening as well. Pray for them all. Paula Crew - Beth, the program earlier I had a question on Fundations. You have taken the Fundations training, is that correct? Beth Moore - Yes, I'm a level one facilitator for Fundations. Paula Crew - What does that mean? What will you be able to do for our students and teachers? Beth Moore - I just really work with first grade. It's so specialized. Is Megan still here? No. So it is so very specialized. You can't just say, I want to be a Fundations trainer and be able to cover kindergarten through third grade. I'm just a level one. That means I am just for first grade level one instruction. It's that specialized. And so I can, although there's some similarities throughout the grades, but I can work with those teachers to ensure that all of our students are getting what they need or figure out ways to make the program better. Paula Crew - Now, thank you for that because I know that was some extra training that you had to do as well. And we have a lot of new curriculum in our district. A lot on our teachers' plates as a result. It's good stuff on their plates, but thank you for working with them and kudos to them. There's a lot that they're doing, but it will be beneficial for our students. We appreciate everything everyone's doing.

Susan Wile - I will finish tomorrow with my LETRS facilitator training, which I'm excited about. I feel like I've mentioned that before, but it has been about 160 hours since the start of August. Paula Crew - Would you please tell what that is? Susan Wile - LETRS is foundational training in the science of reading. It is very comprehensive, starting with what letter sounds we need to teach students and what order we need to teach them, what methods do we use to teach those sounds. And then it goes all the way through to the instruction of comprehension, how we use language structures, how we teach students to both understand and compose complex sentence structures. So again, it's a very comprehensive training. The reason that we decided for me to take facilitator training is we wanted someone in the district to be able to continue that training with our teachers. It's very expensive to have a national facilitator come here and do that training with teachers. So as we have new teachers come into the district, we wanted to be able to continue to provide that training, even though the ESSER money is going away. The best way to do that was to take some of that money and utilize it to get a trained staff member. So I was just complaining about the number of hours that it took, and I went by Renee Shepherd's room before the board meeting and she was talking about ... Renee teaches our Intense Resource Room at the middle school. So a number of her students come to middle school without the ability to read. And she was just sharing how she's utilizing her learning from that program and how well her students are doing. I tried to talk her into bringing her kids here to read to you guys, and she said that makes her too nervous. But really reading much more fluently and doing great things in that class, so that makes it all worth it. That's exciting for me to be able to offer that learning to teachers for years in the future. That's great. Beth Moore - It feels like board tour stuff when they go to the school. Susan Wile - I think you should definitely see Renee's room when you go and see what she's doing with that learning of the science of reading. There are some new operating standards for special education. They were updated over the summer. I've been participating in some training at our county office and at our regional office, just in what those pieces of that new legislation are. There's not major changes, but there are some additional paperwork demands for the district and for teachers, which a little bit of a pet peeve of mine because I would prefer we focus on things like how to implement the science of reading in our classroom. But we'll get there. We'll get that done and get those pieces in place for this year. Then lastly, I just wanted to

say that last week I attended the Hope Walk in Springfield at Wittenberg, and it was during a conference night, so I think a lot of people were not able to attend. But our Hope Squad from the middle school worked with the BATs program, which is a similar mental health group at Springfield High and the Global Stem Academy, and with the Hope Squad from Greenon High. They completely organized this walk. As you walked along the path, there were several stops, and people presented information about suicide prevention and resources in the community that are available to assist families who have experienced suicide and families who are experiencing just mental health struggles to try to prevent suicide. So it was a really good event. I was super impressed with the student's organization of it, and they intend to do it again next year. So hopefully more people will get to participate next year. Paula Crew - Thank you. I just wanted to, again, give kudos to Susan and Beth for doing the two trainings, Fundations and LETRS. A lot of hours, whether it's level one or being able to facilitate. What this will let us do is to sustain the programs that we purchased with the ESSER money, and that's huge. It's huge for our goal one of our strategic plan, that academic growth. So thank you.

Deputy Loney - I got to be at Kathryn's building last week for her conferences, and also the Touch a Truck that she had up there. That was very neat. I think it brought a lot of people to the conferences, just having that there. I got to fulfill the dream of sitting in a trash truck. They had a Rumpke trash truck there. I got to maneuver the trash truck and stuff. That was pretty neat. We did, and it warms your heart, we did bus evacuation drills at the elementaries this week. I know Paula was at Donnelsville. I was at Park Layne. Mr. Dixon had a prior commitment, so he couldn't be there. But it just really impressed me the way Karen and her drivers, just seeing our kids come off the busses and the bigger kids helping our little ones off there. They get that look in their eye. They don't know what to do. To us, it's not really that far of a jump, but to a kindergartener jumping down, it's a big jump. Our bigger kids stood right there and picked them up brought them down. I looked down the line and all the kids were doing that. Bus safety is important, and they did very good in the drills. Our SADD group, we have a program that the Department of Public Safety has. It's called Buckle Up With Brutus. Mr. Mills, I know you're probably going to be happy about this one. But it centers on there's a curriculum that you have to follow and everything. It's focused towards our second and third graders at Donnelsville and New Carlisle. We're starting with... Mrs. Randenburg has a bigger second and third-grade group, so we're going to start at Donnelsville, but it focuses on child safety. And so there's a lot of students in SADD. There's four or five of them that are going to be going into the elementary and presenting this program. So it's neat seeing them work this project. I'm just watching them do it. They're going to do a good job. So we're going in two weeks. We're just finalizing everything. So I look forward to having that program going. And then last week, I got to go to Ohio Christian University and speak with a couple of other SROs in the state. And I've never been to a Christian University. It's a long way down there. It's a long drive. There's no cell service. But it was very neat getting to talk with the other SROs throughout the state and what problems they have and what they're working with. It was really neat to get to go and spend half the morning there and just pick up some things that they're doing. It was a very neat event. It was hosted by Ohio School Safety. Paula Crew - That was a good opportunity and good representation for this area that you got to go and do that, John. Deputy Loney - Yes, very nice. Paula Crew - Well, as always, thank you both for all you do for safety and security here at Tecumseh.

<u>Paula Crew</u> - Last month, we talked about substitute pay for teachers and specifically retired teachers. On a side note, we have a training coming up. Beth, Susan, myself, John, and Brian, and

Veronica Cassidy put on the training. It's a full day training on October 23rd. It was liked and shared almost 80 times, I believe, so that's exciting. We do have at least 20 people who are coming to that training. I do want to tell you it was on social media, and one of the things there was some inaccurate information that said we were the lowest paying district for substitutes. That's not factual. We pay \$100 a day. We wish it were more, of course. Clark Shawnee pays \$95 a day. A couple of the other districts in Clark County pay \$100 a day as well. There's one district that's an outlier, Northwestern pays around \$150 a day. I just wanted to, in case you saw that on social media, those were inaccurate comments that we are not the lowest paying district for our substitutes. But one of the things that Mr. Stafford brought up was the potential of elevating the teacher pay for those who have retired from Tecumseh Local Schools. We wanted to do a little cost analysis of what that would look like for our district. I have from payroll a list of non-bachelor versus bachelor substitutes. Currently, we have, according to what she gave me, four teachers that are retired from Tecumseh that currently sub for our district. If you raised it by \$20 and they hypothetically work the most number of days they could in a year, that would be \$3,680 extra per teacher. It's giving you all the data so you can make a decision or talk this through. No one works 184 days as a substitute. That's the highest that you could do. I just want to give you worst case scenario financially, right, Denise? Denise Robinson - Yeah, you'd have to pay STRS, and workers comp, and Medicare on top of that as well. Paula Crew - Did you have anything that you want to discuss about that? Sue Anne Martin - Why would we not? Roger Diller - And how far do you go with that? I mean, does it just take in two years of college, four years? Paula Crew - Good question. My recommendation is if we do this or if you make a motion to increase that, I truly feel, and I think Mrs Robinson will concur that we can't afford to do that, a blanket increase. Would you concur? Denise Robinson - I would concur. Paula Crew - I don't think we could even do a tier bachelor substitute versus non-bachelor substitute. By the way, right now, we have thirty non-bachelor substitutes and only twenty-five bachelor. If we didn't have those non-bachelor substitutes, we would be in a lot of trouble. Actually, that's one page. The other page, there are forty-one non-bachelors here and fifty-one bachelor. So still, proportionately, we have more non-bachelors' substitutes. But I even wouldn't recommend going as far as saying paying bachelors this and non-bachelors this. That's so hard for payroll. It's also hard to say, I'm a retired teacher from Clark Shawnee, but I want to work here because I live here. I think they need to make the same as all other substitutes. I think the rationale is we elevate our people and reward them for spending their entire careers here. And although it might not monetarily be much to them, really, I think it's more of showing them that we do set them apart from others because they have been a Tecumseh teacher, and they retired from here. Sue Anne Martin - Does that answer your question as you laid it out? How do you feel about the... I mean, right now, it's four people. Four retired Tecumseh Local, retired teachers. Correct? Paula Crew-Yes. I want to tell you, though, if there are people who perhaps don't substitute because perhaps they don't feel valued because they get the same amount as somebody with a high school diploma or somebody who's never worked at Tecumseh like they have for thirty plus years, what I can't tell you is how many that would bring in. That's something I don't have data on because it's unknown until it happens. Roger Diller - Could we base it on that they have a teaching degree? Paula Crew - They'd have to be, in my opinion, a retired Tecumseh teacher. So they'd have to have a degree. Roger Diller - Right. Sue Anne Martin - And if we brought in more retired Tecumseh teachers because of this adjustment, we would be better served in the classroom. Paula <u>Crew</u> - Absolutely. <u>Sue Anne Martin</u> - And so there is a benefit to that for us. <u>Jon Stafford</u> - Well said. Sue Anne Martin - Even if we brought in five or six more, right? Paula Crew - Our teachers, our Tecumseh teachers, and I'm not just saying this, I've been open about this, are the best. So

yes, that would be best for kids in our district. <u>Sue Anne Martin</u> - It would be best for kids. <u>Jon Stafford</u> - So, are you looking for us to make a motion and do this tonight? <u>Paula Crew</u> - I just wanted to... You can. I just wanted to give... Ms. Robinson, do you have anything you want to say since it's financial? <u>Denise Robinson</u> - No.

# Reports (continued):

Paula Crew - I also wanted to talk about just two pieces of legislation that have recently been out there. The first one is Senate Bill 29, and I passed around information on that. I'm not going to go into detail with this. I shared it in your board update. Just wanted to let you know I'm working closely with Veronica because one of the things that we need to do now is to ensure that our contracting with technology providers that we're ensuring appropriate security safeguards for educational records. We're restricting unauthorized access to educational records, and we're restricting use of educational records beyond contract fulfillment. Essentially, all school districts now have to make sure everyone that we contract with meets these needs. I will tell you that our district has joined the EdTech Leaders Alliance, and they've established a consortium there, and everyone is vetted if they've met this and the contract. So Veronica or Beth, because this is technology, but also curriculum. We have a lot of online software. We can go in and just pull that out and use that. We do need to share a link on our website with this, and we are working with Neola. And I know that I've been in two webinars so far. We've heard about it at our county superintendent and treasurer's meeting. The second piece, if you turn the page there that they talk about is the annual August 1 notification. So beginning next year by August 1, each school district must notify parents and students of any curriculum, testing or assessment technology provider contract affecting a student's educational record. So again, we're going to put that online. And then the last page, the thing that concerned me the most was now any time that we monitor, if you will, a student, electronically, we need to notify parents within 72 hours, in writing, that we've monitored them and tell them why. There's a couple of things that we have in the district that make that extremely concerning and would be very laborious for all of our educators, our safety personnel, our administrators. One such thing, is called Securely. I think we have that at middle and high school. So what that would do is that Ms. Crameen, for example, she's monitoring on her computer what everybody's doing on their Chromebooks, so she can actually monitor what they're doing, which is a wonderful thing. According to Senate Bill 29, I hope you don't mind me using you, Ms. Crameen. She would have to notify every day, I'm checking on John today. I'm checking on... That was really concerning, and that's how it was yesterday. The client alert came out yesterday afternoon, thankfully. It's a document, good news, I have written here that this does not include daily things. Our general notice that's posted on the website now will encompass all of those things that we do on a regular basis. The things that we will have to notify parents in writing within 72 hours. I have a couple of examples. We have something called

Safety Bot that the principals and our safety team and myself receive. It's a Likert scale of 1-5, five being the most worrisome. It can be anything from, I'm feeling very sad if that's typed in our email, to, I'm contemplating self-harm, which would come across as a five. We all receive those emails and act immediately to look into those. Now with Senate Bill 25, which goes into effect on October 24th, we will have to, in writing, send to each parent. So Brian typed something up that we were alarmed, and Ms. Tally called him down and talked with him about it. Some communication has to go home. We haven't quite figured out what that's going to look like yet to let the parents know. Sue Anne Martin - So email, text, parent square? Paula Crew - We could. Sue Anne Martin - Writing. I mean, like a physical? Paula Crew - It could be electronic. Sue Anne Martin - It hasn't been defined. Paula Crew - Writing. Sue Anne Martin - Okay. Paula Crew - So more to come on that. But our safety team and our administrators, we're all working on Senate Bill 29. Veronica, I know Denise with contracts, etc.

The next one I wanted to chat about is House Bill 214. That's the religious accommodations that I alluded to earlier. Basically, the board will need to adopt a policy that and I'm going to read it, that reasonably accommodates the sincerely held religious beliefs and practices of individual students with regard to all examinations or other academic requirements and absences for reasons of faith or religious or spiritual belief system. Our policy that you need to adopt is going to outline that students are allowed to take three days for religious holidays, and forthcoming will be a list of those approved religious holidays. It's not there yet, although this does go into effect in nine days on October 24th, just like Senate Bill 29. I did reach out to Neola today, and they said they had not started working on that policy yet. We're in a crunch. The cart came before the horse again with legislation. I'll keep you updated. Sue Anne Martin - We have to accommodate this without direction. Paula Crew - Yes. Sue Anne Martin - Okay. Paula Crew - What we're seeing a little bit is just the pendulum, which continues through the years to sway back and forth. We're beginning to see that pendulum flow back toward the allowing of religion, religious practices, and the policy.
