## Superintendent's Report

#### **Reserve Plan – Emily Peavey**

Mrs. Peavey reported that, as of 6/30/2022, the Restricted General Fund Balance will be \$3,128,436.59. Please note that with Proposition 4, which is listed on the ballot for the budget vote on May 17<sup>th</sup>, there is no cost to the tax payer. This Proposition for the Athletic Pavilion Project is funded by the existing Capital Reserve Fund (\$1,100,000) and unappropriated Fund Balance .
