In partnership with families and the community, our goal is to create relevant learning opportunities for students both inside and outside the classroom that help them develop the knowledge and character necessary to succeed in a technologically advanced world. Students will have success for today and be prepared for tomorrow. Every student matters and serves a purpose. We strive to provide high-quality education individualized for each student by developing and maintaining relationships with families and the community. One way we continue to do this is by participating in the Title I, Part A State Program. This program provides funding for low socioeconomic schools. In return, we promise to meet the expectations laid out for us by the Texas Education Agency and the United States Department of Education. **ESSA 1116 (a)(2) and ESSA 1116 (e)(3)**

Parents and families are a child's first teacher. They imitate you from the moment they are born. Therefore, a mutually beneficial relationship between school and home is in the best interest of every child. The expectation of our PFE Program is to foster communication and decision-making with parents about student performance and to collaboratively support learning. Our objectives are:

- Effective two-way communication between school and home which is linked to a higher completion rate on homework, better attention during instructional tasks, increased participation by all parties, and improved interactions and relationships between parents, teachers, and students.
- Upon request, to the extent feasible and appropriate, WISD will provide translation support services. **ESSA 1116 (e)(5)**
- If a child's parents are more involved in school experiences, the child is more likely to have higher grades, improved behavior, better attendance, higher social skills, and adaptation.
- Learning together leads to better school and home life.
- Being a life-long learner can prevent some health issues that often occur later in life.

Title I funds will be allocated for the implementation of the parent and family engagement program. Such programs, activities and procedures will be planned and implemented with meaningful consultation with parents of participating children.

**Staff / Parent Communications**

The district, with the assistance of its school and parents, will educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents. District personnel will implement and coordinate parent programs and build ties between parents and school. **ESSA 1116(e)(3)**

When Wildorado receives STAAR test results, an email and text message will be sent out to parents announcing that test results are available to view. Parents can access the results on the Wildorado ISD website by creating an account in the Ascender Parent Portal. Parents may call the school to get the Parent Portal ID number that is unique for each student. Parents are encouraged to ask questions of staff members on how to interpret the results of the STAAR test and/or attend the parent meetings in the Fall to learn about interpreting the STAAR test information.

## **Evaluation**

Wildorado Independent School District will take action to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of schools. The evaluation will include identifying barriers to greater participation by parents in parental engagement activities with particular attention to parents who are economically disadvantaged, disabled, limited English proficient, limited literacy, or are of any racial or ethnic minority background. The school district will use the findings of the evaluation about its parental engagement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary and with the involvement of parents, its parental engagement policies.

Wildorado ISD utilizes several types of formative assessments. Each child is assessed in a system which is modeled after the State of Texas Assessments of Academic Readiness or STAAR test. Examples include: TFAR; and TEKS Resource System. Previous STAAR tests are released which are utilized for assessment and instruction in addition to other curriculums.

WISD tracks each child's growth throughout the year via local assessments (mentioned above). Each child has a way to keep up with the tracking (with the teacher's help), so they know where they are in their own learning and growth.
