# **2022-2023 Budget**

## **Budget Expenditures**


State law requires the 2022-2023 budget to be presented in 3 parts: program, administrative, and capital.

**Program -** This component is intended to provide every student with educational experiences and opportunities to foster the full development of his or her potential. This budget category includes all instructional personnel and programs: regular school, special education, library, media, instructional technology, guidance, student health services, school psychologists, attendance and census costs, music, cocurricular activities, athletics, in-district and out-of-district pupil transportation, and staff development.

**Administrative -** This component is intended to provide the necessary support for district functions. This category includes all expenses for the Board of Education, superintendent, business office, auditor, tax collection, fiscal agent, legal services, personnel office, records management, public information, central printing and mailing, property and casualty insurance, school association dues, BOCES administrative share, and supervision of instruction.

**Capital -** This component is intended to provide a safe and healthy learning environment for students, staff and the community. This budget category includes all personnel, equipment, supplies, and materials for the operation and maintenance of district facilities. Any judgments and claims, refunds of real property taxes, and all payments of principal and interest on short- and long-term obligations are included in this category. In the 2022-23 budget is a small (\$100,000) capital project for Reynolds Elementary School communications system and site work project.



# Summary of Proposition II & III

### **Proposition II:**

#### Annual Bus Purchase

The bus fleet consists of 87 large (64 passenger) buses, 13 medium (15-38 passenger and wheelchair capable) buses, 14 Class A Van Style (15 passenger and wheelchair capable) buses, and 4 Suburban-type vehicles and 2 Tahoe (DOT Inspected Vehicles). Buses are used for about 12 years, and the Suburban-type vehicles are used for about 10 years. In order to maintain the District's approved replacement schedule, approximately 11 to 14 buses should be replaced per year.

Capital Improvement Project consisting of the reconstruction and renovation of, and the construction of improvements, additions and upgrades to Durgee Junior High School.


Projected Project Cost: \$32,800,000
State Building Aid: \$24,774,129



# Summary of Proposition IV & V

### **Proposition IV:**

2022 Capital Reserve Fund

The creation of the "2022 Capital Reserve Fund" with \$10,000,000 to defray the cost of construction and reconstruction of School District buildings, facilities and grounds, including original equipment, machinery, apparatus, appurtenances, furnishings, and other incidental improvements and expenses.

This proposition is not contingent upon the passage of the budget or Proposition II, III or V.

### **Proposition V:**

Land Acquisition

Allow the Board of Education to purchase property located in the town of Van Buren for \$10,000. The property consists of about .22 acres of vacant land on O'Brien Road and will be used to allow bus traffic and parent traffic to be separated at McNamara Elementary.

Purchase Cost: \$10,000 State Building Aid: \$8,790 Local Share: \$1,210

This proposition is not contingent upon the passage of the budget or Proposition II, III or IV.

#### **Estimated Tax Rate**

In Lysander and Van Buren, the tax rate is projected to increase by **2.28%** assuming assessments do not rise. The estimated tax rate will be as shown below. Please note that the district will not receive assessments and equalization rates\* for the towns of Van Buren, Lysander and Clay until August. At that time, the actual tax levy and tax rates will be calculated.

The proposed tax levy increase of 2.28% will likely result in a lower tax rate per \$1,000 of assessed value. The overall assessed property values, taking equalization rates into account, continues to increase. The increased assessed property values provides a larger base to divide the levy over which results in the tax rate per \$1,000 being lower. This has occurred over the past 4 years, though your tax bill may increase due to an increase in the assessed value of your home. In summary, the assessed value increase of an entire geographical area does not necessarily result in the same percentage increase on each tax bill. True tax rate per thousand with no change in total assessed values projects a tax rate of \$22.72.

**\*About Equalization Rates --** An equalization rate represents the average level of assessment in each community. For example, an equalization rate of 50% means that, on average, the property is being assessed at 50% of its market value. The equalization rates are determined by the NYS Board of Equalization and Assessment. One of the most important uses of the equalization rate is to divide the tax levy fairly among municipalities in the same school district. In the Baldwinsville Central School District, the municipalities are the towns of Lysander, Van Buren and Clay.

#### Example of how your tax bill is calculated

Example of a tax bill if my property has an assessed value of \$250,000, and the projected tax rate is \$22.72 per \$1,000 of assessed value my tax bill will be approximately \$5,680 not including exemptions.

#### Formula

(Tax rate/thousand) x assessed value (\$22.72/\$1,000) x \$100,000 = \$2,272 (Tax rate/thousand) x assessed value (\$22.72/\$1,000) x \$250,000 = \$5,680

# What Happens If the Budget is Defeated?

#### The Board has 3 options:

- 1. Put the same budget back before voters
- 2. Reduce the budget and ask voters to approve budget
- 3. Go directly to a contingent budget with no re-vote

If the budget is defeated twice, the board must adopt a contingent budget, which may not increase the current tax levy by any amount.

# How will a contingent budget affect the school district?

Under a contingent budget, there will be no instructional or non-instructional equipment purchases and no community use of facilities unless groups or organizations pay all associated costs. Further cuts from programs and administration would be required to conform to spending caps.

# **Capital Project**

The \$32.8 million capital project will allow the District to make renovations and improvements to Durgee Junior High School.

The work at Durgee involves construction of a new gymnasium and STEAM space. The project also includes the reconstruction and reconfiguration of the existing technology, music and art space, media center, kitchen, cafeteria and gymnasium. The main office will be housed near the nurses office and guidance to create a safe and secure main entrance off the bus loop. Upgrades to the building's infrastructure are also included in the project.

The \$32.8 million project will be funded by \$24.8 million in State Building Aid, \$5 million from the Capital Reserve Fund and \$3 million raised from taxes. Taxes are projected to increase by approximately \$12.77 for a home with a

market value of \$100,000 to support the project beginning in 2024-2025.

This capital improvement project initially involved multiple phases, however the plans for the 2022 capital improvement project were scaled back to be financially responsible during this time. The proposed work does not currently include realignment of grade levels, renovations at Ray, second floor additions at Durgee, or any major renovations of fields and parking on the main campus. This proposed work was carefully thought out to support the current students in the Durgee building, while also allowing for future work that could support grade level realignment in the future. The Facilities Committee is continuing to work on the next capital project proposal to ensure we continue to improve our infrastructure. The scaled back project drastically decreases the impact to the taxpayers.
