Superintendent's Budget Message

From Acting Superintendent Dr. Kathleen Davis

Dear Baldwinsville School District Community:

The Board of Education adopted



the budget spending plan of \$129,154,122 for the 2023–24 school year at the March 20 meeting.

The budget is focused on students and

learning, and there are many supports in place to address the academic, social and emotional needs of our students. Our goal is to provide a program so each child is college and career ready. This year, the district is fully funded by Foundation Aid by the State of New York. This increase in Foundation Aid comes at a good time as the Covid-19 American Rescue Plan (ARPA) grants drop off. This great news allows us to keep needed supports in place for students.

A new High-Impact Tutoring Set Aside (\$827,000) mandate is included within 2023–24 Foundation Aid. This set aside requires districts with a Foundation Aid increase above a certain level to use some of that increase to support new small group or individual tutoring sessions in reading and math to students in grades 3–8 at risk of falling below state standards. Please understand this set aside may be removed in the final state budget. These funds would then be applied toward our music program.

Our staff and administrative team along with our community budget

advisory committees, helped to inform the district as the budget was developed. The budget speaks to children while being fiscally responsible by staying within the levy limit. Some of the highlights are:

- Music Instruments for Grades 3–5, Marching Band Personnel
- Athletic Personnel (Assistant Varsity Coaches) & Potential Head Coaches for New Programs

We have been working on our strategic plan as a Board of Education, leadership team, faculty, staff and community to align our focus on the mission, vision and district goals for the future. Our goal is to foster an environment to educate and empower all students today to become global citizens of tomorrow. It has been a productive time in our district as we plan forward. Our team is committed to student growth and overcoming barriers.

Students and the instructional supports reflected in this budget are supported through a fiscally sound proposed spending plan. The proposed 2023–24 tax levy is a 2.85 percent increase from the 2022–23 budget.

The tax levy limit requires districts in New York State to apply a multi-step formula to determine the tax levy increase a district can propose. We will once again stay within this tax levy limit. Many years of financial planning has helped us to build a budget that supports student-centered learning and is fiscally responsible.





What a 'no vote' means

If the 2023–24 budget is defeated May 16, the school board may choose between a contingency budget or putting the same or a revised budget to a second vote. If the same or revised budget is also defeated, the board

Contingency Budgets

must operate on a contingency budget. With the establishment of the Property Tax Cap, the spending cap on contingent budgets was removed; instead, the tax levy can be no greater than the prior year actual tax levy. In addition, school districts must adhere to the contingent budget administrative cap, which, for Baldwinsville, is the administrative percent of the program and administrative components in the 2022–23 school year (10.09 percent). A contingency budget would result in reductions in equipment purchases and no community use of facilities unless groups or organizations pay all associated costs. Reductions from program and administration would need to be made to be in compliance with spending caps. The Board of Education determines which appropriations constitute ordinary contingent expenses.

Budget 2023–24 Propositions

2023-24 Budget

Shall the proposed budget of One Hundred Twenty-Nine Million, One Hundred Fifty-Four Thousand, One Hundred Twenty-Two Dollars (\$129,154,122) for the Baldwinsville Central School District as recommended by the Board of Education for the fiscal year beginning July 1, 2023, be adopted and shall the Board of Education be authorized to levy the necessary taxes therefor?

Student Transport Vehicles

Shall the Board of Education of the Baldwinsville Central School District be authorized to purchase and finance fourteen (14) student transport vehicles, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$2,202,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$2,202,000, shall be issued?

Capital Project

Ш Shall the Baldwinsville Central School District be authorized to undertake a capital improvement project consisting of the reconstruction and renovation of, and the construction of improvements, additions and upgrades to various District buildings and facilities and the sites thereof, the purchase of original furnishings, equipment, machinery and apparatus required in connection with the purposes for which such buildings, facilities and sites are used. all to include site, access, parking, athletic field and playfield improvements, demolition, utility, mechanical, plumbing and electrical improvements as well as payment of professional fees and all other necessary costs incidental to such work and expend therefore a total sum not to exceed \$63,900,000, which is estimated to be the total maximum cost thereof, and to pay for the Project by (i) spending \$3,551,106 together with any unexpended amounts on deposit in the District's existing Capital Reserve Fund approved by the voters in May of 2019 and thereafter terminate such reserve fund, (ii) spending \$3,948,894 from the District's existing Capital Reserve Fund approved by the voters in May of 2022, and (iii) by the levy of a tax which is hereby voted in the amount of \$56,400,000, subject to available State aid or to any other revenues available for such purpose, which tax shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$56,400,000, and a tax is hereby voted to pay the principal and interest on said obligations when due?

2023 Capital Reserve Fund

Shall the Baldwinsville Central School District be authorized to establish a new ten-year capital reserve pursuant to Section 3651 of the Education Law in an amount not to exceed \$10,000,000 to be used for renovations and additions to all District facilities, including the purchase of equipment, technology upgrades, classroom equipment and/or school infrastructure equipment, security and safety improvement, site development, athletic fields, plumbing, storm and sanitary sewers, boilers, driveways, and parking lots, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2023 and each fiscal year thereafter for the term of the reserve fund, (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, and (iv) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law?

Land Acquisition

Shall the Baldwinsville Central School District be authorized to undertake a project consisting of the acquisition of a parcel of land with dimensions of approximately 64.00 x 215.00 located at 7715 Maple Road, Town of Van Buren, County of Onondaga and State of New York, identified Section, Block and Lot number 030.-04.23.0, including all structures located thereon and payment of all necessary costs incidental to such acquisition and expend therefore a total sum not to exceed \$44,000, which is estimated to be the total maximum cost thereof, and to pay for the Project by the levy of a tax which is hereby voted in the amount of \$44,000, subject to available State aid or to any other revenues available for such purpose, which tax shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$44,000, and a tax is hereby voted to pay the principal and interest on said obligations when due?

Capital Outlay

State law provides that a district may receive building aid in the following school year for one project each year, not to exceed \$100,000. These projects must be paid by budget appropriation (no borrowing) and require full voter authorization. This year the Board of Education has decided to include a capital outlay project for McNamara Elementary Communications Systems, Site Work and Office Reconstruction.



Capital Project









The majority of work for the proposed capital project will be at Ray Middle School, C.W. Baker High School and the athletic complex located on the district's main campus. The project proposal also includes minor infrastructure upgrades at Durgee Junior High School and Elden Elementary School. Highlights include:

Baker High School

- Gym expansion with a raised indoor track and locker room refresh (pictured top left)
- Pool relocation with six lanes (pictured center left)
- Science wing renovation with STEAM upgrades (pictured bottom left)
- A new Multipurpose Turf Field for Athletics and the Arts
- Access road for parent drop-off/pickup

Ray Middle School

- Renovated classrooms including fine and performing arts, ensemble as well as new collaboration and breakout spaces and an ageappropriate outdoor wellness space
- Gymnasium and locker room reconfigurations
- Site work upgrades, including the bus loop and green spaces to provide safe traffic flow

School Board Elections

The community will have the opportunity to vote for four board members. Three board positions are for three-year terms commencing July 1, 2023. The candidates receiving the highest votes will serve in the three-year terms. The candidate with the fourth highest vote will serve from May 17, 2023 until June 30, 2024. Below are the photos and biographies that each candidate submitted.

Luke Gasowski

In 2016, my wife (a teacher), along with our two children, moved to Baldwinsville. We came to the district because of the exemplary and outstanding education the school district offered, along with its inclusive special education program.

Proposed budget goes to voters May 16

The Baldwinsville Board of Education adopted a proposed budget of \$129,154,122 for the 2023–24 school year, with a tax levy increase of 2.85 percent, which is within the district's tax levy cap.

The vast majority of the budget — 78.24 percent — will go toward programs that support student learning needs. Starting next year, the district will be fully funded by State Foundation Aid, which will be used to keep the tax rate low and

offset expiring grants that support Covid-era learning gaps, as well as mental health needs.

The community will have the opportunity to weigh in on the district's proposed 2023–24 spending plan during the budget vote and school board election on May 16 from 6 a.m. to 9 p.m. at the District Operations Building.
